Section 223.001, Transportation Code, is amended by amending Subsection (b) and adding Subsection (c) to read as 6 follows: 7 Except as provided by Subsection (c) and Section 8 (b) 223.042(c), the [The] department shall submit for competitive bids 9 each contract for: 10 11 (1) the improvement of a highway; 12 (2) materials to be used in the construction or 13 maintenance of a highway; or 14 (3) traffic control or safety devices to be used on a highway. 15 16 (c) The department may award a contract described by Subsection (b)(2) or (3) as a purchase of goods under Subtitle D, 17 Title 10, Government Code, if the department: 18 (1) estimates that the contract will involve an amount 19 for which the comptroller has delegated purchasing authority for 20 21 the purchase of goods to state agencies under rules adopted by the comptroller under Subchapter C, Chapter 2155, Government Code; and 22 (2) determines that the competitive bidding procedure 23 24 in this chapter is not practical.

S.B. No. 1270 1 SECTION 2. Section 223.042(c), Transportation Code, is 2 amended to read as follows:

3 (c) The department may award a contract under this section 4 as a purchase of service under Subtitle D, Title 10, Government 5 Code, if the department:

6 (1) estimates that the contract will involve an amount 7 for which <u>the comptroller has delegated</u> [a formal solicitation 8 process for the purchase of services is not required under rules 9 relating to the delegation of] purchasing authority <u>for the</u> 10 <u>purchase of services</u> to state agencies <u>under rules</u> adopted by the 11 comptroller under Subchapter C, Chapter 2155, Government Code; and

12 (2) determines that the competitive bidding procedure13 in this chapter is not practical.

14 SECTION 3. The change in law made by this Act applies only 15 to a contract for which the Texas Department of Transportation first advertises or otherwise solicits bids, proposals, offers, or 16 17 qualifications or makes a similar solicitation on or after the effective date of this Act. A contract for which the Texas 18 Transportation first advertises or 19 Department of otherwise solicits bids, proposals, offers, or qualifications or makes a 20 similar solicitation before the effective date of this Act is 21 governed by the law in effect on the date the advertisement or 22 solicitation is made, and that law is continued in effect for that 23 24 purpose.

25 SECTION 4. This Act takes effect immediately if it receives 26 a vote of two-thirds of all the members elected to each house, as 27 provided by Section 39, Article III, Texas Constitution. If this

Act takes effect September 1, 2021.
