- 1 SECTION 3. Subchapter B, Chapter 32, Human Resources Code,
- 2 is amended by adding Section 32.026101 to read as follows:
- 3 Sec. 32.026101. DETERMINATION OF ELIGIBILITY BY HEALTH CARE
- 4 EXCHANGES PROHIBITED. (a) The commission may not accept Medicaid
- 5 eligibility determinations from an exchange established under 42
- 6 U.S.C. Section 18041(c).
- 7 (b) The commission may accept eligibility assessments from
- 8 an exchange, but the commission must determine the eligibility of
- 9 an individual for Medicaid.
- 10 SECTION 4. If before implementing any provision of this Act
- 11 a state agency determines that a waiver or authorization from a
- 12 federal agency is necessary for implementation of that provision,
- 13 the agency affected by the provision shall request the waiver or
- 14 authorization and may delay implementing that provision until the
- 15 waiver or authorization is granted.
- SECTION 5. This Act takes effect September 1, 2021.
