Section 111.003(a), Local Government Code, is amended to read as follows: 6 (a) Not later than the 60th day before the first day [During 7 the 7th or the 10th month] of the fiscal year, [as determined by the 8 9 commissioners court,] the county judge, assisted by the county auditor or county clerk, shall prepare a budget to cover all 10 proposed expenditures of the county government for the succeeding 11 12 fiscal year. 13 SECTION 2. Section 111.006(a), Local Government Code, is 14 amended to read as follows: 15 (a) Not later than the 60th day before the first day of the fiscal year [When the county judge has completed the preparation of 16 the budget], the county judge shall file a copy of the proposed 17 budget with the county clerk. 18 SECTION 3. Sections 111.007(b) and (c), Local Government 19 20 Code, are amended to read as follows: 21 (b) The commissioners court shall <u>hold</u> [set] the hearing <u>not</u> later than the 10th [for a date after the 15th] day after [of the 22 month next following] the day [month in which] the budget is filed 23 under [was prepared in accordance with] Section 111.006 [111.003, 24

1 Local Government Code], but before the date <u>the commissioners court</u>
2 <u>adopts the county's ad valorem tax rate for the current tax year</u> [on
3 <u>which taxes are levied by the court</u>].

4 The commissioners court shall give public notice that it (c) 5 will consider the proposed budget on the date of the hearing. The notice must state the date, time, and location of the hearing. 6 The notice must include, in type of a size at least equal to the type 7 8 used for other items in the notice, any statement required to be included in the proposed budget under Section 111.003(b). The 9 commissioners court shall give notice under this subsection: 10

11 (1) not earlier than the 30th day before the date of 12 the hearing; and

13(2) not later than the 10th day before the date of the14hearing.

15 SECTION 4. Section 111.008(a), Local Government Code, is 16 amended to read as follows:

(a) <u>After</u> [At] the conclusion of the public hearing <u>but not</u>
<u>later than the 10th day before the first day of the fiscal year</u>, the
commissioners court shall take action on the proposed budget. A
vote to adopt the budget must be a record vote.

21 SECTION 5. Section 111.033(a), Local Government Code, is 22 amended to read as follows:

(a) <u>Not later than the 60th day</u> [Within 30 days] before the first day of each fiscal year [or on or immediately after that first day], the county auditor shall prepare a budget to cover the proposed expenditures of the county government for that fiscal year.

1 SECTION 6. Section 111.037(a), Local Government Code, is 2 amended to read as follows:

3 (a) Not later than the 60th day before the first day of the
4 <u>fiscal year, the</u> [The] county auditor shall file a copy of the
5 proposed budget with the county clerk.

6 SECTION 7. Sections 111.038(b) and (c), Local Government 7 Code, are amended to read as follows:

8 (b) The commissioners court shall hold the hearing <u>not later</u> 9 <u>than the 10th</u> [on a] day [within 10 calendar days] after the <u>day</u> 10 [date] the proposed budget is filed <u>under Section 111.037</u> but 11 before <u>the date the commissioners court adopts the county's ad</u> 12 <u>valorem tax rate for the current tax year</u> [the last day of the first 13 month of the fiscal year].

14 (c) The commissioners court shall publish notice that it 15 will consider the proposed budget on the date of the budget hearing. 16 The notice must be published once in a newspaper of general 17 circulation in the county and must state the date, time, and 18 location of the hearing. <u>The commissioners court shall give notice</u> 19 under this subsection:

20 (1) not earlier than the 30th day before the date of 21 the hearing; and 22 (2) not later than the 10th day before the date of the

24 SECTION 8. Section 111.039(a), Local Government Code, is 25 amended to read as follows:

26 (a) <u>After [At]</u> the conclusion of the public hearing <u>but not</u>
 27 <u>later than the 10th day before the first day of the fiscal year</u>, the

commissioners court shall take action on the proposed budget. A
 vote to adopt the budget must be a record vote.

3 SECTION 9. The changes in law made by this Act apply to a 4 budget proposed by a county commissioners court for a fiscal year 5 beginning on or after the effective date of this Act.

6 SECTION 10. This Act takes effect immediately if it 7 receives a vote of two-thirds of all the members elected to each 8 house, as provided by Section 39, Article III, Texas Constitution. 9 If this Act does not receive the vote necessary for immediate 10 effect, this Act takes effect September 1, 2021.
