Section 533.004(a), Government Code, is amended to read as follows: 6 7 (a) In providing health care services through Medicaid managed care to recipients in a health care service region, the 8 9 commission shall contract with a managed care organization in that region that is licensed under Chapter 843, Insurance Code, if 10 subject to that chapter, to provide health care in that region and 11 12 that is: 13 (1) wholly owned and operated by a hospital district 14 in that region; 15 (2) created by a nonprofit corporation that: 16 (A) has а contract, agreement, or other arrangement with a hospital district in that region or with a 17 municipality in that region that owns a hospital licensed under 18 Chapter 241, Health and Safety Code, and has an obligation to 19 20 provide health care to indigent patients; and 21 (B) under the contract, agreement, or other 22 arrangement, assumes the obligation to provide health care to 23 indigent patients and leases, manages, or operates a hospital facility owned by the hospital district or municipality; [or] 24

1 (3) created by a nonprofit corporation that has a 2 contract, agreement, or other arrangement with a hospital district 3 in that region under which the nonprofit corporation acts as an 4 agent of the district and assumes the district's obligation to 5 arrange for services under the Medicaid expansion for children as 6 authorized by Chapter 444, Acts of the 74th Legislature, Regular 7 Session, 1995; or

8 <u>(4) a provider-sponsored health organization</u> 9 <u>affiliated with two trauma facilities designated as level I trauma</u> 10 <u>facilities by the Department of State Health Services under Section</u> 11 <u>773.115, Health and Safety Code, provided the commission does not</u> 12 <u>have an existing contract with a managed care organization under</u> 13 Subdivision (1).

14 SECTION 2. The changes in law made by this Act apply only to 15 the award of a contract by the Health and Human Services Commission 16 on or after the effective date of this Act.

17 SECTION 3. If before implementing any provision of this Act 18 a state agency determines that a waiver or authorization from a 19 federal agency is necessary for implementation of that provision, 20 the agency affected by the provision shall request the waiver or 21 authorization and may delay implementing that provision until the 22 waiver or authorization is granted.

23 SECTION 4. This Act takes effect immediately if it receives 24 a vote of two-thirds of all the members elected to each house, as 25 provided by Section 39, Article III, Texas Constitution. If this 26 Act does not receive the vote necessary for immediate effect, this 27 Act takes effect September 1, 2021.
