Notwithstanding any other law, a participating entity 9 10 may not offer or make available to the entity's employees or their dependents group health coverage not provided under the program. 11 12 SECTION 2. Subchapter D, Chapter 1579, Insurance Code, is 13 amended by adding Section 1579.155 to read as follows: 14 Sec. 1579.155. PROGRAM PARTICIPATION: ELECTION. 15 Effective September 1, 2022, a participating entity may elect to discontinue the entity's participation in the program by providing 16 17 written notice to the trustee not later than December 31 of the year preceding the first day of the plan year in which the election will 18 be effective. 19 (b) A participating entity that elects to discontinue 20 participation in the program under Subsection (a) may not elect to: 21 22 (1) participate in the program until the fifth

anniversary of the effective date of the entity's election to

- 6 (e) Not later than November 1, 2022, each committee shall
- 7 submit to the governor, the lieutenant governor, the speaker of the
- 8 house of representatives, each standing committee of the senate or
- 9 house of representatives having primary jurisdiction over public
- 10 education or public retirement systems, the commissioner of the
- 11 Texas Education Agency, and the executive director of the Teacher
- 12 Retirement System of Texas a written report on the study conducted
- 13 by the committee under this section.
- 14 (f) This section expires January 1, 2023.
- 15 SECTION 4. Sections 1579.1045 and 1579.155, Insurance Code,
- 16 as added by this Act, apply only to group coverage provided for a
- 17 plan year beginning on or after September 1, 2022. A plan year that
- 18 begins before that date is governed by the law as it existed
- 19 immediately before the effective date of this Act, and that law is
- 20 continued in effect for that purpose.
- 21 SECTION 5. This Act takes effect September 1, 2021.
