S.B. No. 1490

A BILL TO BE ENTITLED

1 AN ACT

- 2 relating to the authority of the Texas Higher Education
- 3 Coordinating Board to authorize certain degree programs offered by
- 4 private postsecondary educational institutions.
- 5 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF TEXAS:
- 6 SECTION 1. Section 61.303, Education Code, as amended by
- 7 S.B. 1781, Acts of the 85th Legislature, Regular Session, 2017, is
- 8 amended by reenacting and amending Subsection (c) and adding
- 9 Subsection (c-1) to read as follows:
- 10 (c) Except as provided by Subsection (c-1), the [The] board
- 11 may approve the issuance of a certificate of authorization to grant
- 12 degrees [issue] to an exempt institution or person [a certificate
- 13 of authorization to grant degrees]. The board may adopt rules
- 14 regarding a process to allow an exempt institution or person to
- 15 apply [for] and receive approval for a certificate of authorization
- 16 under this section.
- 17 <u>(c-1)</u> The board may not approve the issuance of a
- 18 certificate of authorization for an exempt institution to grant a
- 19 professional degree or to represent that credits earned in this
- 20 state are applicable toward a professional degree if the
- 21 <u>institution</u> is chartered in another state or has its principal
- 22 office or primary educational program in another state unless the
- 23 institution is an authorized institution operating under a State
- 24 Authorization Reciprocity Agreement (SARA). In this subsection,

- 1 "professional degree" includes Doctor of Medicine (M.D.), Doctor of
- 2 Osteopathy (D.O.), Doctor of Dental Surgery (D.D.S.), Doctor of
- 3 Veterinary Medicine (D.V.M.), Juris Doctor (J.D.), and Bachelor of
- 4 Laws (LL.B.).
- 5 SECTION 2. Section 61.306, Education Code, is amended by
- 6 amending Subsections (a) and (c) and adding Subsections (c-1) and
- 7 (d) to read as follows:
- 8 (a) Subject to Subsections (c) and (c-1), the [The] board
- 9 may issue a certificate of authority to grant a degree or degrees
- 10 and to enroll students for courses which may be applicable toward a
- 11 degree if it finds that the applicant meets the standards
- 12 established by the board for certification.
- 13 (c) The board may not issue a certificate of authority for a
- 14 private postsecondary educational institution to grant a
- 15 professional degree or to represent that credits earned in this
- 16 state are applicable toward a professional degree if the
- 17 institution is chartered in a foreign country or has its principal
- 18 office or primary educational program in a foreign country.
- 19 (c-1) The board may issue a certificate of authority for a
- 20 private postsecondary educational institution to grant a
- 21 professional degree or to represent that credits earned in this
- 22 state are applicable toward a professional degree only if the board
- 23 determines that:
- 24 (1) the capacity and ability of similar professional
- 25 degree programs at institutions of higher education and private or
- 26 independent institutions of higher education are insufficient to
- 27 meet the state's current market needs;

1 (2) the institution seeking the certificate of 2 authority: 3 (A) has the necessary faculty and other resources 4 to ensure student success; and 5 (B) is subject to and agrees to meet the same standards for approval and all academic criteria applicable to 6 7 similar professional degree programs offered by institutions of higher education and private or independent institutions of higher 8 9 education; and 10 (3) sufficient placements are available to students 11 for required field-based experience, such as clinicals or 12 clerkships, for the proposed professional degree. (d) In this section: 13 (1) "Institution of higher education" and "private or 14 15 independent institution of higher education" have the meanings 16 assigned by Section 61.003. 17 (2) "Professional [subsection, "professional] degree" 18 includes a Doctor of Medicine (M.D.), Doctor of Osteopathy (D.O.), Doctor of Dental Surgery (D.D.S.), Doctor of Veterinary Medicine 19

(D.V.M.), Juris Doctor (J.D.), and Bachelor of Laws (LL.B.).

SECTION 3. This Act takes effect September 1, 2021.
