A BILL TO BE ENTITLED

AN ACT

- 2 relating to the use of hotel occupancy tax revenue by certain
- 3 municipalities and the authority of certain municipalities to
- 4 pledge that revenue, and to receive and pledge certain other
- 5 revenue, for the payment of obligations related to a hotel and
- 6 convention center project.
- 7 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF TEXAS:
- 8 SECTION 1. Section 351.10712(a), Tax Code, is amended to

- (e) A municipality to which this section applies is not entitled to receive revenue under Subsection (d) unless the municipality commences a qualified project under this subchapter before September 1, 2025 [2023].
- SECTION 4. This Act takes effect immediately if it receives a vote of two-thirds of all the members elected to each house, as provided by Section 39, Article III, Texas Constitution. If this Act does not receive the vote necessary for immediate effect, this Act takes effect September 1, 2021.
