## A BILL TO BE ENTITLED

- 2 relating to identification requirements for early voting by mail.
- 3 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF TEXAS:
- 4 SECTION 1. Section 84.001(b), Election Code, is amended to
- 5 read as follows:
- 6 (b) An application must be in writing and signed by the
- 7 applicant <u>using ink on paper</u>. An electronic signature <u>or</u>
- 8 photocopied signature is not permitted.
- 9 SECTION 2. Section 84.002(a), Election Code, is amended to
- 10 read as follows:
- 11 (a) An early voting ballot application must include:
- 12 (1) the applicant's name and the address at which the
- 13 applicant is registered to vote;
- 14 (1-a) the following information:
- 15 <u>(A) the applicant's driver's license number or</u>
- 16 the number of a personal identification card issued by the
- 17 Department of Public Safety; or
- 18 (B) if the applicant has not been issued a number
- 19 described by Paragraph (A), the last four digits of the applicant's
- 20 <u>social security number;</u>
- 21 (2) for an application for a ballot to be voted by mail
- 22 on the ground of absence from the county of residence, the address
- 23 outside the applicant's county of residence to which the ballot is

- 2 on the ground of age or disability, the address of the hospital,

- 5 (3-a) a space for entering the information required

- 7 (4) on an application for a ballot to be voted by mail:
- 8 (A) a space for an applicant applying on the
- 9 ground of absence from the county of residence to indicate the date
- 10 on or after which the applicant can receive mail at the address

- 13 applicant whose application is signed by a witness cannot make the

- 7 (I) a statement informing the applicant of the

- 9 SECTION 4. Section 86.001, Election Code, is amended by
- 10 adding Subsection (f) to read as follows:
- 11 (f) If the information required under Section

- 14 under Section 13.002(c)(8), the clerk shall reject the application.

- 1 SECTION 6. Section 87.041(b), Election Code, is amended to
- 2 read as follows:
- 3 (b) A ballot may be accepted only if:
- 4 (1) the carrier envelope certificate is properly
- 5 executed;
- 6 (2) neither the voter's signature on the ballot
- 7 application nor the signature on the carrier envelope certificate
- 8 is determined to have been executed by a person other than the
- 9 voter, unless signed by a witness;
- 10 (3) the voter's ballot application states a legal
- 11 ground for early voting by mail;
- 12 (4) the voter is registered to vote, if registration
- 13 is required by law;
- 14 (5) the address to which the ballot was mailed to the

- 2 SECTION 7. The changes in law made by this Act apply only to
- 3 an application to vote an early voting ballot by mail submitted on
- 4 or after the effective date of this Act. An application to vote an
- 5 early voting ballot by mail submitted before the effective date of
- 6 this Act is governed by the law in effect when the application was
- 7 submitted, and the former law is continued in effect for that
- 8 purpose.
- 9 SECTION 8. This Act takes effect September 1, 2021.
