Subchapter A, Chapter 33, Human Resources Code, is amended by adding Section 33.019 to read as follows: 22 23 Sec. 33.019. SIMPLIFIED CERTIFICATION AND RECERTIFICATION 24 REQUIREMENTS FOR CERTAIN SNAP APPLICANTS AND RECIPIENTS. (a) The

No. 1532 commission shall develop and implement simplified certification 1 and recertification requirements for supplemental nutrition 2 3 assistance program benefits for individuals who are 60 years of age or older and who reside in a household in which every individual 4 5 residing in the household is 60 years of age or older. The simplified requirements must: 6 7 (1) allow an individual described by this section to 8 waive recertification interview requirements; (2) simplify and reduce the number of verification 9 requirements for certifying and recertifying eligibility to 10 receive benefits, which must include the use of a shortened 11 12 application form; and (3) allow the individual to remain eligible for 13 benefits for 36 months after certification and after each 14 recertification. 15 (b) An individual described by this section is required to: 16 17 (1) submit to the commission a change reporting form every 12 months during the 36-month eligibility period; and 18 (2) report to the commission, in accordance with 19 federal law, when the individual receives an increase in income. 20 21 (c) The commission shall, in a manner that complies with 22 federal law, use data matching to help enroll in the supplemental nutrition assistance program eligible individuals described by 23 24 this section who are receiving Medicaid benefits. The commission may seek or use private funding or contract with a public or private 25 26 entity to carry out this section. SECTION 3. Section 33.019, Human Resources Code, as added 27

by this Act, applies only to an application or recertification of
eligibility of a person for supplemental nutrition assistance
program benefits submitted on or after January 1, 2022.

4 SECTION 4. If before implementing any provision of this Act 5 a state agency determines that a waiver or authorization from a 6 federal agency is necessary for implementation of that provision, 7 the agency affected by the provision shall request the waiver or 8 authorization and may delay implementing that provision until the 9 waiver or authorization is granted.
