BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF TEXAS: SECTION 1. Sections 40.0041(a), (b), (c), (d), (e), and (f), Human Resources Code, are amended to read as follows: (a) The executive commissioner by rule shall develop and implement a uniform process for <u>the commission's office of the</u> ombudsman to receive [<del>recolving</del>] and <u>resolve</u> [<del>recolving</del>] complaints against the department throughout the state. The process shall include: (1) statewide procedures through which the public, consumers, and service recipients are informed: (A) of the right to make a complaint against the department, including the mailing addresses and telephone numbers of appropriate [<del>department</del>] personnel within the office of the <u>ombudsman</u> responsible for receiving complaints and providing related assistance; and (B) of the [<del>department's</del>] procedures <u>of the</u> <u>office of the ombudsman</u> for resolving a complaint, including the right to appeal a decision made at the local level <u>by department</u> (2) development and statewide distribution of a form or telephone system that may be used to make a complaint; (3) a requirement that the <u>office of the ombudsman</u> for investigating and resolving a complaint to each person who makes a complaint; and (4) a requirement that the <u>office of the ombudsman</u> [<del>department]</del> provide status information <u>at least quarterly to a</u> person with a pending complaint against the department, unless the information would jeogradize an undercover investigation.
