8	than February 20 of each year, a county that imposes the tax	
9	authorized by this chapter shall report to the comptroller:

11	(A) the tax imposed by the county under this	
12	<pre>chapter; and</pre>	
13	(B) if applicable, the tax imposed by the county	
14	under Subchapter H, Chapter 334, Local Government Code; and	
15	(2) the amount of revenue collected during the	
16	<pre>county's preceding fiscal year from:</pre>	
17	(A) the tax imposed by the county under this	
18	<pre>chapter; and</pre>	
19	(B) if applicable, the tax imposed by the county	
20	under Subchapter H, Chapter 334, Local Government Code.	
21	(b) The county must make the report required by this section	
22	<u>by:</u>	
23	(1) submitting the report to the comptroller on a form	
24	<pre>prescribed by the comptroller; or</pre>	

- 1 (2) providing the comptroller a direct link to, or a
- 2 clear statement describing the location of, the information
- 3 required to be reported that is posted on the Internet website of
- 4 the county.
- 5 (c) Subject to Subsection (b)(2), the comptroller shall
- 6 prescribe the form a county must use for the report required to be
- 7 <u>submitted under this section.</u>
- 8 <u>(d)</u> The comptroller may adopt rules necessary to administer
- 9 this section.
- 10 SECTION 2. As soon as practicable, but not later than
- 11 January 1, 2022, the comptroller of public accounts shall prescribe
- 12 the form required by Section 352.009(c), Tax Code, as added by this
- 13 Act.
- 14 SECTION 3. A county shall submit the initial report or
- 15 otherwise provide the initial information required by Section
- 16 352.009, Tax Code, as added by this Act, not later than February 20,
- 17 2022.
- 18 SECTION 4. This Act takes effect immediately if it receives
- 19 a vote of two-thirds of all the members elected to each house, as
- 20 provided by Section 39, Article III, Texas Constitution. If this
- 21 Act does not receive the vote necessary for immediate effect, this
- 22 Act takes effect September 1, 2021.
