In this chapter: 10 (1) "Donor information" means a list, record, 11 12 registry, roster, or other compilation of any data that directly or indirectly identifies a person as a member, supporter, or volunteer 13 of, or a donor of financial or nonfinancial support to, an entity 14 exempt from federal income tax under Section 501(a), Internal 15 16 Revenue Code of 1986, by being listed as an exempt organization under Section 501(c)(3), (4), or (6), Internal Revenue Code of 17 1986. 18 (2) "Public agency" means a state or 19 local governmental unit, including: 20 21 (A) this state or a department, agency, office, commission, board, division, or other entity of this state in the 22 23 executive branch of state government; 24 (B) any state or local court or other judicial or

PROTECTED DONOR INFORMATION. 6 (a) 7 Notwithstanding any other law except Section 3001.003, a public agency or an officer or <u>employee of a public agency may not</u>: 8 9 (1) require an individual to provide donor information 10 to the agency or otherwise compel the release of donor information; 11 (2) require an entity exempt from federal income tax 12 under Section 501(a), Internal Revenue Code of 1986, by being listed as an exempt organization under Section 501(c), Internal 13 Revenue Code of 1986, to provide donor information to the agency or 14 otherwise compel the release of donor information; 15 (3) release, publicize, or otherwise publicly 16 17 disclose donor information in the agency's possession; or (4) request or require a current or prospective 18 19 contractor with or grantee of the agency to provide to the agency a list of organizations exempt from federal income tax under Section 20 501(a), Internal Revenue Code of 1986, by being listed as exempt 21 organizations under Section 501(c), Internal Revenue Code of 1986, 22 to which the contractor or grantee has provided financial or 23 24 nonfinancial support. 25 (b) Donor information is excepted from release under 26 Chapter 552. 27 Sec. 3001.003. EXCEPTIONS. Section 3001.002 does not apply

described in Paragraph (A) for each intentional violation; and 1 2 (3) court costs, including reasonable attorney's and 3 witness fees. 4 Sec. 3001.005. IMMUNITY WAIVED. A person who alleges a 5 violation of Section 3001.002 may sue the public agency for the 6 relief provided under Section 3001.004. Sovereign or governmental 7 immunity, as applicable, is waived and abolished to the extent of liability for that relief. 8 9 Sec. 3001.006. CRIMINAL PENALTY. A person commits an offense if the person violates Section 3001.002. An offense under 10 this section is a Class B misdemeanor. 11 SECTION 2. Chapter 3001, Government Code, as added by this 12 Act, applies only to donor information released or disclosed on or 13 after the effective date of this Act. 14 15 SECTION 3. This Act takes effect September 1, 2021.
