## A BILL TO BE ENTITLED

	AN ACT

- 2 relating to the creation of a joint interim committee to study
- 3 colonias and colonia initiatives in this state.
- 4 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF TEXAS:
- 5 SECTION 1. INTERIM COMMITTEE; STUDY. (a) In this section,
- 6 "colonia" has the meaning assigned by Section 2306.581, Government
- 7 Code.
- 8 (b) A joint interim committee is established to study
- 9 colonias and colonia initiatives in this state.
- 10 (c) The joint interim committee is composed of the members
- 11 of the standing committees of the legislature with primary
- 12 jurisdiction over colonias and colonia issues. The committee
- 13 members shall select a presiding officer from among the membership.
- 14 (d) In conducting the study under this section, the joint
- 15 interim committee shall:
- 16 (1) determine the best methods for updating and
- 17 maintaining colonia identification systems and for identifying and
- 18 classifying colonias in which the highest public health risks
- 19 exist;
- 20 (2) consider whether colonias should be defined
- 21 uniformly across all relevant state agencies and whether that
- 22 definition should include essential metrics such as:
- 23 (A) economic mobility levels;
- 24 (B) poverty levels;

- 1 (C) mortality rates;
- 2 (D) health professional shortage area scores;
- 3 and
- 4 (E) the average level of education attained by
- 5 colonia residents;
- 6 (3) to address the enduring lack of services and
- 7 infrastructure in colonias, assess best practices and funding needs
- 8 for surveying the services and infrastructure available in, and
- 9 demographics of, each colonia;
- 10 (4) assess the status of state agency tracking and
- 11 reporting of state-funded colonia projects and whether
- 12 improvements to the tracking or reporting mechanisms are necessary;
- 13 (5) determine and assess any non-infrastructure needs
- 14 within colonias and options for this state to address those needs;
- 15 and
- 16 (6) assess the impact of the COVID-19 pandemic on
- 17 colonias and whether additional state services are necessary to
- 18 address those impacts.
- 19 (e) The joint interim committee has all other powers and
- 20 duties provided to a special or select committee by the rules of the
- 21 senate and house of representatives, by Subchapter B, Chapter 301,
- 22 Government Code, and by policies of the senate and house committees
- 23 on administration.
- 24 (f) Not later than September 1, 2022, the joint interim
- 25 committee shall prepare and submit to the governor, the lieutenant
- 26 governor, the speaker of the house of representatives, and the
- 27 legislature a written report that includes the findings of the

- 1 committee under this section, including any legislative
- 2 recommendations.
- 3 SECTION 2. ABOLITION OF COMMITTEE. The joint interim
- 4 committee established by Section 1 of this Act is abolished and this
- 5 Act expires November 1, 2022.
- 6 SECTION 3. EFFECTIVE DATE. This Act takes effect September
- 7 1, 2021.
