- 6 SECTION 1. Section 121.003, Agriculture Code, is amended by
- 7 adding Subsection (e) to read as follows:
- (e) Not later than the 90th day after the date a change to a 8
- 9 state statute, federal statute, or federal regulation takes effect,
- the department shall submit to the secretary of the United States 10
- Department of Agriculture any amendments to the state plan 11
- necessary to incorporate and implement the change. 12
- SECTION 2. Subchapter A, Chapter 122, Agriculture Code, is 13
- 14 amended by adding Section 122.005 to read as follows:
- Sec. 122.005. HEMP RESEARCH BY INSTITUTIONS OF HIGHER 15
- EDUCATION. (a) The department shall issue a license to an 16
- institution of higher education in this state that requests the 17
- license. 18

- (b) Notwithstanding any provision of this chapter or 19
- department rule other than Subsection (c), an institution of higher 20
- 21 education conducting research involving hemp:
- (1) is not required to pay a fee collected by the 22
- department under this chapter; 23
- 24 (2) is not required to obtain from the department a lot

- 1 crop permit or other permit for each location where hemp is grown;
- 2 (3) is not required to obtain preharvest testing under
- 3 Section 122.153 before harvesting plants, except as provided by
- 4 Subsection (c);
- 5 (4) may use hemp seed and cultivate and handle plants
- 6 grown from seed that is not certified or approved under Section
- 7 <u>122.252; and</u>
- 8 (5) is not subject to Section 122.403(c) or (d).
- 9 <u>(c) An institution of higher education may not sell or</u>
- 10 transfer hemp to another person unless the institution complies
- 11 with the requirements of Sections 122.153 and 122.356.
- 12 SECTION 3. Section 122.051, Agriculture Code, is amended by
- 13 adding Subsection (c) to read as follows:
- 14 (c) Not later than the 90th day after the date a change to
- 15 this chapter, a federal statute, or a federal regulation takes
- 16 effect, the department shall propose any rules necessary to
- 17 incorporate and implement the change.
- 18 SECTION 4. Section 122.151, Agriculture Code, is amended by
- 19 adding Subsection (g) to read as follows:
- 20 (g) A laboratory that performs testing required by this
- 21 chapter shall report the delta-9 tetrahydrocannabinol
- 22 concentration, the total tetrahydrocannabinol concentration, and
- 23 any other federally regulated cannabinoid of the sample on a dry
- 24 weight basis and the measurement of uncertainty in the test result.
- 25 The measurement of uncertainty must comply with International
- 26 Organization for Standardization ISO/IEC 17025 or a comparable or
- 27 successor standard. For purposes of this chapter, the delta-9

- 1 tetrahydrocannabinol concentration of the sample is the lowest
- 2 possible value given that measurement of uncertainty.
- 3 SECTION 5. Section 122.201(a), Agriculture Code, is amended
- 4 to read as follows:
- 5 (a) A license holder shall harvest the plants from a plot
- 6 not later than the 30th [20th] day after the date a preharvest
- 7 sample is collected under Section 122.154 unless field conditions
- 8 delay harvesting or the department authorizes the license holder to
- 9 delay harvesting. This subsection does not prohibit the license
- 10 holder from harvesting the plants immediately after the preharvest
- 11 sample is collected.
- 12 SECTION 6. Subchapter E, Chapter 122, Agriculture Code, is
- 13 amended by adding Section 122.203 to read as follows:
- 14 Sec. 122.203. HARVEST WHILE LICENSE SUSPENDED OR REVOKED.
- 15 (a) A person whose license is suspended or revoked after planting
- 16 hemp plants may obtain preharvest or postharvest testing under
- 17 Subchapter D and may harvest the plants under Section 122.201 in the
- 18 same manner as a license holder.
- 19 (b) While a person's license is suspended or revoked, the
- 20 <u>dep</u>artment may:
- 21 (1) prohibit the person from selling or using plants
- 22 harvested <u>under Subsection (a); or</u>
- 23 (2) if the delta-9 tetrahydrocannabinol concentration
- 24 of the plants is not more than 0.3 percent on a dry weight basis,
- 25 allow the person to sell or use plants harvested under Subsection
- 26 (a) in the same manner as a license holder under Section 122.202.
- 27 (c) A person whose license is reinstated may sell or use

- 1 plants harvested under Subsection (a) as provided by Section
- 2 122.202.
- 3 SECTION 7. The heading to Subchapter F, Chapter 122,
- 4 Agriculture Code, is amended to read as follows:
- 5 SUBCHAPTER F. HEMP SEED AND PLANTS
- 6 SECTION 8. Section 122.252, Agriculture Code, is amended to
- 7 read as follows:
- 8 Sec. 122.252. CERTIFICATION OR APPROVAL OF SEED AND PLANT
- 9 VARIETIES. (a) The department or an entity authorized to certify
- 10 seed <u>and plants</u> under Chapter 62 shall identify and certify or
- 11 approve varieties of seed and plants confirmed to produce hemp.
- 12 (b) The department or entity may not certify or approve a
- 13 variety of hemp seed or plant if the variety [seed] is tested and
- 14 confirmed to produce a plant that has delta-9 tetrahydrocannabinol
- 15 concentration of more than 0.3 percent on a dry weight basis. For
- 16 purposes of this subsection, the department may partner with a
- 17 private entity or an institution of higher education to test seed
- 18 and plant varieties for the purpose of certification or approval
- 19 under this section.
- 20 (c) The department may authorize the importation of hemp
- 21 seed and plant varieties certified in accordance with the law of
- 22 another state or jurisdiction that requires as a condition of
- 23 certification that hemp be produced in compliance with:
- 24 (1) that state or jurisdiction's plan approved by the
- 25 United States Department of Agriculture under 7 U.S.C. Section
- 26 1639p; or
- 27 (2) a plan established under 7 U.S.C. Section 1639q if

- 1 that plan applies in the state or jurisdiction.
- 2 (d) The department shall maintain and make available to
- 3 license holders a list of hemp <u>seed and plant varieties</u> [<del>seeds</del>]
- 4 certified or approved under this section.
- 5 SECTION 9. Subchapter F, Chapter 122, Agriculture Code, is
- 6 amended by adding Section 122.254 to read as follows:
- 7 Sec. 122.254. SEEDLINGS AND OTHER IMMATURE PLANTS. (a) In
- 8 this section, "immature plant" means a hemp seedling, clone, or
- 9 cutting that requires substantial cultivation and further growth
- 10 before the beginning of the period under Section 122.201(a) when
- 11 the plant may be harvested.
- 12 <u>(b) A person may transport into this state, and a license</u>
- 13 holder may obtain and cultivate, immature plants propagated outside
- 14 this state if the plants are accompanied by shipping documentation
- 15 <u>that:</u>
- (1) complies with any requirements of the state of
- 17 origin;
- 18 (2) indicates the grower of the immature plants is
- 19 licensed by the state of origin;
- 20 (3) lists the recipient license holder in this state
- 21 and the recipient's license number; and
- 22 (4) shows that the variety of the immature plants is
- 23 <u>certified or approved under Section 122.252.</u>
- 24 (c) A license holder may obtain and cultivate immature
- 25 plants propagated in this state by another license holder if the
- 26 plants are accompanied by the shipping certificate or cargo
- 27 manifest required by Section 122.055 that shows that the variety of

- 1 the immature plants is certified or approved under Section 122.252.
- 2 The immature plants are not subject to preharvest testing under
- 3 Section 122.153.
- 4 (d) A license holder may transplant immature plants
- 5 propagated by the license holder from one plot to another plot
- 6 controlled by the license holder. The department by rule shall
- 7 waive the requirement that a license holder obtain a lot crop permit
- 8 and not require any fee for a greenhouse or other location used to
- 9 propagate immature plants if the plants are transplanted to another
- 10 plot controlled by the license holder and are not sold or
- 11 transferred to another person. The department by rule shall waive
- 12 the requirement that a person obtain a shipping certificate or
- 13 cargo manifest to transplant immature plants from one plot to
- 14 another plot operated by the license holder.
- 15 SECTION 10. Section 122.403, Agriculture Code, is amended
- 16 by amending Subsection (a) and adding Subsection (e) to read as
- 17 follows:
- 18 (a) If the department determines that a license holder
- 19 negligently violated this chapter or a rule adopted under this
- 20 chapter, the department shall enforce the violation in the manner
- 21 provided by 7 U.S.C. Section 1639p(e) and 7 C.F.R. Section 990.6.
- 22 <u>(e) A license holder may not receive more than one negligent</u>
- 23 <u>violation of the same kind per growing season.</u>
- SECTION 11. Subchapter I, Chapter 122, Agriculture Code, is
- 25 amended by adding Section 122.4035 to read as follows:
- Sec. 122.4035. PENALTIES FOR CULTIVATING HEMP WITHOUT A
- 27 LICENSE; CRIMINAL OFFENSE. (a) On determining that a person

Subchapter A, Chapter 443, Health and Safety Code, is amended by adding Sections 443.005 and 443.006 to read as follows: Sec. 443.005. CONSUMABLE HEMP PRODUCTS ACCOUNT. (a) The 10 consumable hemp products account is an account in the general 11 12 revenue fund administered by the department. (b) The account consists of: 13 14 (1) appropriations of money to the account by the 15 legislature; 16 (2) public or private gifts, grants, or donations, 17 including federal funds, received for the account; 18 (3) fees collected under this chapter or under Chapter 19 431 as it applies to consumable hemp products; 20 (4) interest and income earned on the investment of money in the account; 21 (5) penalties for violations of this chapter or 22 Chapter 431 as it applies to consumable hemp products; and 23 24 (6) funds from any other source deposited in the 25 account.

- 11 (1) has a delta-9 tetrahydrocannabinol concentration
- 12 of more than 0.3 percent on a dry weight basis;
- 13 (2) has a total tetrahydrocannabinol concentration of
- 14 more than one percent on a dry weight basis;
- 15 (3) exceeds any federal limit; or
- 16 (4) has been adulterated with additional
- 17 tetrahydrocannabinol or synthetic tetrahydrocannabinol.

- SECTION 13. Section 443.103, Health and Safety Code, is
- 24 amended to read as follows:
- Sec. 443.103. APPLICATION; ISSUANCE. An individual or
- 26 establishment may apply for a license under this subchapter by
- 27 submitting an application to the department on a form and in the

- 1 manner prescribed by the department. The application must be
- 2 accompanied by:
- 3 (1) the physical address [a legal description] of each
- 4 location where the applicant intends to process hemp or manufacture

- 19 Sec. 443.106. CHANGE OF OWNERSHIP. The department may
- 20 change ownership to another person if:
- 21 (1) the current license holder and the recipient apply
- 22 to the department for the change of ownership;
- 23 (2) the recipient is not ineligible to hold a license

- 25 (3) one party to the change of ownership submits any

- 27 SECTION 15. Section 443.152, Health and Safety Code, is

- 8 SECTION 16. Section 443.201, Health and Safety Code, is
- 9 amended by adding Subsection (c) to read as follows:
- 10 (c) A person may transport and deliver a consumable hemp
- 11 product to a consumer who purchased the product in compliance with
- 12 this chapter. The person transporting and delivering the consumable
- 13 hemp product is not required to:
- 14 (1) obtain a license under Section 443.101, unless the
- 15 person processes or manufactures the product delivered; or
- 16 (2) register under Section 443.2025, unless the person
- 17 sells the product delivered.
- 18 SECTION 17. The heading to Section 443.2025, Health and
- 19 Safety Code, is amended to read as follows:
- Sec. 443.2025. REGISTRATION REQUIRED FOR RETAILERS AND
- 21 DISTRIBUTORS OF CERTAIN PRODUCTS.
- 22 SECTION 18. Section 443.2025, Health and Safety Code, is

- 12 under Subsection (b) if the person, as an employee or independent
- 13 contractor of a person located outside this state who is not a
- 14 registrant, sells or distributes products covered by Subsection (b)
- 15 in this state.
- 16 (f) The department by rule may adopt a registration fee
- 17 schedule that establishes reasonable fee amounts for the
- 18 registration of:
- 19 (1) a single location at which consumable hemp
- 20 products containing <u>more than trace amounts of cannabinoids</u>
- 21 [cannabidiol] are sold; and
- 22 (2) multiple locations at which consumable hemp
- 23 products containing more than trace amounts of cannabinoids
- 24 [cannabidiol] are sold under a single registration.
- 25 SECTION 19. Section 443.203, Health and Safety Code, is
- 26 amended by adding Subsection (c) to read as follows:
- 27 (c) A person who sells, offers for sale, or distributes a

- 1 consumable hemp product that the person claims is made in this state
- 2 commits a false, misleading, or deceptive act or practice
- 3 <u>actionable under Subchapter E, Chapter 17, Business & Commerce</u>
- 4 Code, if the product contains any hemp that was not grown and
- 5 processed in this state by license holders under Chapter 122,
- 6 Agriculture Code and Chapter 443, Health and Safety Code.
- 7 SECTION 20. Section 122.403, Agriculture Code, as amended
- 8 by this Act, and Section 122.4035, Agriculture Code, as added by
- 9 this Act, apply only to conduct that occurs on or after the
- 10 effective date of this Act. Conduct that occurred before that date
- 11 is governed by the law in effect when the conduct occurred, and the
- 12 former law is continued in effect for that purpose.
- 13 SECTION 21. This Act takes effect September 1, 2021.
