S.B. No. 1780

A BILL TO BE ENTITLED

1 AN ACT

- 2 relating to the protection of public health in this state,
- 3 including through the establishment of the Texas Epidemic Public
- 4 Health Institute at The University of Texas Health Science Center
- 5 at Houston.
- 6 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF TEXAS:
- 7 SECTION 1. Section 61.003(6), Education Code, is amended to
- 8 read as follows:
- 9 (6) "Other agency of higher education" means The
- 10 University of Texas System, System Administration; The University
- 11 of Texas at El Paso Museum; Texas Epidemic Public Health Institute
- 12 at The University of Texas Health Science Center at Houston; The
- 13 Texas A&M University System, Administrative and General Offices;
- 14 Texas A&M AgriLife Research; Texas A&M AgriLife Extension Service;
- 15 Rodent and Predatory Animal Control Service (a part of the Texas A&M
- 16 AgriLife Extension Service); Texas A&M Engineering Experiment
- 17 Station (including the Texas A&M Transportation Institute); Texas
- 18 A&M Engineering Extension Service; Texas A&M Forest Service; Texas
- 19 Division of Emergency Management; Texas Tech University Museum;
- 20 Texas State University System, System Administration; Sam Houston
- 21 Memorial Museum; Panhandle-Plains Historical Museum; Cotton
- 22 Research Committee of Texas; Texas Water Resources Institute; Texas
- 23 A&M Veterinary Medical Diagnostic Laboratory; and any other unit,
- 24 division, institution, or agency which shall be so designated by

- 1 statute or which may be established to operate as a component part
- 2 of any public senior college or university, or which may be so
- 3 classified as provided in this chapter.
- 4 SECTION 2. Chapter 75, Education Code, is amended by adding
- 5 Subchapter D to read as follows:
- 6 SUBCHAPTER D. TEXAS EPIDEMIC PUBLIC HEALTH INSTITUTE
- 7 Sec. 75.301. DEFINITIONS. In this subchapter:
- 8 (1) "Board" means the board of regents of The
- 9 University of Texas System.
- 10 (2) "Health science center" means The University of
- 11 Texas Health Science Center at Houston.
- 12 (3) "Institute" means the Texas Epidemic Public Health
- 13 Institute.
- Sec. 75.302. ESTABLISHMENT. The board shall establish and
- 15 maintain the Texas Epidemic Public Health Institute at the health
- 16 science center.
- Sec. 75.303. ROLE AND SCOPE. The institute shall establish
- 18 and maintain a public health reserve network of public health
- 19 professionals, community health workers, state and local public
- 20 health agencies, health care organizations, universities
- 21 throughout the state, and other relevant entities and persons for
- 22 the purpose of coordinating efforts to:
- 23 (1) protect public health in this state; and
- 24 (2) support pandemic and epidemic disaster
- 25 preparedness and response components of the state emergency
- 26 management plan required by Section 418.042, Government Code.
- 27 <u>Sec. 75.304. ADMINISTRATION. (a) The administration of</u>

- 1 the institute is under the direction of the chancellor of The
- 2 University of Texas System and the board through the president of
- 3 the health science center.
- 4 (b) The Department of State Health Services shall provide
- 5 the institute with access to relevant and timely data necessary for
- 6 the institute to perform its duties.
- 7 Sec. 75.305. GIFTS, GRANTS, AND DONATIONS. The institute
- 8 may accept gifts, grants, and donations from any source for the
- 9 purposes of the institute.
- 10 Sec. 75.306. INDEPENDENT FINANCIAL AUDIT FOR REVIEW BY
- 11 COMPTROLLER. (a) The institute biennially shall commission an
- 12 independent financial audit of its activities from a certified
- 13 public accounting firm. The institute shall provide the audit to
- 14 the comptroller.
- 15 (b) The comptroller shall review and evaluate the audit and
- 16 biennially issue a public report of that review.
- Sec. 75.307. APPROPRIATION CONTINGENCY. The board is
- 18 required to implement a provision of this subchapter only if the
- 19 legislature appropriates money specifically for that purpose. If
- 20 the legislature does not appropriate money specifically for that
- 21 purpose, the board may, but is not required to, implement the
- 22 provision using other money available to the board for that
- 23 purpose.
- SECTION 3. Section 418.042(a), Government Code, is amended
- 25 to read as follows:
- 26 (a) The division shall prepare and keep current a
- 27 comprehensive state emergency management plan. The plan may

- 1 include:
- 2 (1) provisions for prevention and minimization of
- 3 injury and damage caused by disaster;
- 4 (2) provisions for prompt and effective response to
- 5 disaster;
- 6 (3) provisions for emergency relief;
- 7 (4) provisions for energy emergencies;
- 8 (5) identification of areas particularly vulnerable
- 9 to disasters:
- 10 (6) recommendations for zoning, building
- 11 restrictions, and other land-use controls, safety measures for
- 12 securing mobile homes or other nonpermanent or semipermanent
- 13 structures, and other preventive and preparedness measures
- 14 designed to eliminate or reduce disasters or their impact;
- 15 (7) provisions for assistance to local officials in
- 16 designing local emergency management plans;
- 17 (8) authorization and procedures for the erection or
- 18 other construction of temporary works designed to protect against
- 19 or mitigate danger, damage, or loss from flood, fire, or other
- 20 disaster;
- 21 (9) preparation and distribution to the appropriate
- 22 state and local officials of state catalogs of federal, state, and
- 23 private assistance programs;
- 24 (10) organization of manpower and channels of
- 25 assistance;
- 26 (11) coordination of federal, state, and local
- 27 emergency management activities;

- 1 (12) coordination of the state emergency management
- 2 plan with the emergency management plans of the federal government;
- 3 (13) coordination of federal and state energy
- 4 emergency plans;
- 5 (14) provisions for providing information to local
- 6 officials on activation of the Emergency Alert System established
- 7 under 47 C.F.R. Part 11;
- 8 (15) a database of public facilities that may be used
- 9 under Section 418.017 to shelter individuals during a disaster,
- 10 including air-conditioned facilities for shelter during an extreme
- 11 heat disaster and fortified structures for shelter during a wind
- 12 disaster;
- 13 (16) provisions for quickly replenishing the food
- 14 supplies of area food banks or food pantries following a disaster;
- 15 [and]
- 16 (17) provisions for protecting public health; and
- 17 (18) other necessary matters relating to disasters.
- SECTION 4. This Act takes effect September 1, 2021.
