A BILL TO BE ENTITLED

1 AN ACT

- 2 relating to the regulation of providers of certain Medicaid
- 3 services to persons with an intellectual or developmental

- 5 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF TEXAS:
- 6 SECTION 1. Section 142.003(a), Health and Safety Code, is
- 7 amended to read as follows:
- 8 (a) The following persons need not be licensed under this
- 9 chapter:
- 10 (1) a physician, dentist, registered nurse,
- 11 occupational therapist, or physical therapist licensed under the
- 12 laws of this state who provides home health services to a client
- 13 only as a part of and incidental to that person's private office
- 14 practice;
- 15 (2) a registered nurse, licensed vocational nurse,
- 16 physical therapist, occupational therapist, speech therapist,
- 17 medical social worker, or any other health care professional as
- 18 determined by the department who provides home health services as a
- 19 sole practitioner;
- 20 (3) a registry that operates solely as a clearinghouse
- 21 to put consumers in contact with persons who provide home health,
- 22 hospice, habilitation, or personal assistance services and that
- 23 does not maintain official client records, direct client services,
- 24 or compensate the person who is providing the service;

- 1 (4) an individual whose permanent residence is in the
- 2 client's residence;
- 3 (5) an employee of a person licensed under this
- 4 chapter who provides home health, hospice, habilitation, or
- 5 personal assistance services only as an employee of the license
- 6 holder and who receives no benefit for providing the services,
- 7 other than wages from the license holder;
- 8 (6) a home, nursing home, convalescent home, assisted
- 9 living facility, special care facility, or other institution for
- 10 individuals who are elderly or who have disabilities that provides
- 11 home health or personal assistance services only to residents of
- 12 the home or institution;
- 13 (7) a person who provides one health service through a
- 14 contract with a person licensed under this chapter;
- 15 (8) a durable medical equipment supply company;
- 16 (9) a pharmacy or wholesale medical supply company
- 17 that does not furnish services, other than supplies, to a person at
- 18 the person's house;
- 19 (10) a hospital or other licensed health care facility
- 20 that provides home health or personal assistance services only to
- 21 inpatient residents of the hospital or facility;
- 22 (11) a person providing home health or personal
- 23 assistance services to an injured employee under Title 5, Labor
- 24 Code;
- 25 (12) a visiting nurse service that:
- 26 (A) is conducted by and for the adherents of a
- 27 well-recognized church or religious denomination; and

- 1 (B) provides nursing services by a person exempt
- 2 from licensing by Section 301.004, Occupations Code, because the
- 3 person furnishes nursing care in which treatment is only by prayer
- 4 or spiritual means;
- 5 (13) an individual hired and paid directly by the
- 6 client or the client's family or legal guardian to provide home
- 7 health or personal assistance services;
- 8 (14) a business, school, camp, or other organization
- 9 that provides home health or personal assistance services,
- 10 incidental to the organization's primary purpose, to individuals
- 11 employed by or participating in programs offered by the business,
- 12 school, or camp that enable the individual to participate fully in
- 13 the business's, school's, or camp's programs;
- 14 (15) a person or organization providing
- 15 sitter-companion services or chore or household services that do
- 16 not involve personal care, health, or health-related services;
- 17 (16) a licensed health care facility that provides
- 18 hospice services under a contract with a hospice;
- 19 (17) a person delivering residential acquired immune
- 20 deficiency syndrome hospice care who is licensed and designated as
- 21 a residential AIDS hospice under Chapter 248;
