- 2 relating to the possession of property to be acquired by eminent
- 3 domain during pending litigation in a condemnation proceeding.
- 4 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF TEXAS:
- 5 SECTION 1. Section 21.021, Property Code, is amended by
- 6 amending Subsections (a) and (c), and adding Subsection (e) to read
- 7 as follows:
- 8 (a) Not earlier than the 180th day after the date [After]
- 9 the special commissioners [have] made an award in a condemnation
- 10 proceeding, except as provided by Subsection (c) or (e) [of this
- 11 section], the condemnor may take possession of the condemned
- 12 property pending the results of further litigation if the
- 13 condemnor:
- 14 (1) pays to the property owner the amount of damages
- 15 and costs awarded by the special commissioners or deposits that
- 16 amount of money with the court subject to the order of the property
- 17 owner;
- 18 (2) deposits with the court either the amount of money
- 19 awarded by the special commissioners as damages or a surety bond in
- 20 the same amount issued by a surety company qualified to do business
- 21 in this state, conditioned to secure the payment of an award of
- 22 damages by the court in excess of the award of the special
- 23 commissioners; and
- 24 (3) executes a bond that has two or more good and

- 1 solvent sureties approved by the judge of the court in which the
- 2 proceeding is pending and conditioned to secure the payment of
- 3 additional costs that may be awarded to the property owner by the
- 4 trial court or on appeal.
- 5 (c) This state, a county, or a municipal corporation or an
- 6 irrigation, water improvement, or water power control district
- 7 created under legal authority:
- 8 <u>(1) may take immediate possession of the property</u>
- 9 after paying or depositing money as required by Subsection (a)(1);
- 10 <u>and</u>
- 11 (2) is not required to deposit a bond or the amount
- 12 equal to the award of damages under Subsections (a)(2) and (3)
- 13 [Subdivisions (2) and (3) of Subsection (a)].
- 14 (e) This section may not be construed to prohibit an
- 15 agreement between the parties allowing the condemnor immediate
- 16 possession of the property pending resolution of further
- 17 litigation.
- 18 SECTION 2. The changes in law made by this Act apply only to
- 19 a condemnation proceeding for which a petition is filed on or after
- 20 the effective date of this Act. A condemnation proceeding for which
- 21 a petition is filed before the effective date of this Act is
- 22 governed by the law in effect on the date the petition is filed, and
- 23 that law is continued in effect for that purpose.
- SECTION 3. This Act takes effect September 1, 2021.
