1-19 A BILL TO BE ENTITLED
 1-20 AN ACT

1-21 relating to the applicability of uniform grant and contract
 1-22 management standards to certain Texas Water Development Board
 1-23 programs.

1-24 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF TEXAS:

1-25 SECTION 1. Section 15.008, Water Code, is amended to read as
 1-26 follows:

1-27 Sec. 15.008. GRANT STANDARDS. The law regarding uniform
 1-28 grant [~~grants~~] and contract management, Chapter 783, Government
 1-29 Code, does not apply to a contract under Subchapter F, H, I, K, or P,
 1-30 or to a contract relating to an economically distressed area or
 1-31 nonborder colonia under Subchapter C.

1-32 SECTION 2. Section 16.458, Water Code, is amended to read as
 1-33 follows:

1-34 Sec. 16.458. APPLICABLE LAW. (a) Subchapter E, Chapter 17,
 1-35 applies to financial assistance made available from the resiliency
 1-36 fund, except that the board may execute contracts as necessary to
 1-37 evidence grant agreements.

1-38 (b) The law regarding uniform grant and contract
 1-39 management, Chapter 783, Government Code, does not apply to a
 1-40 contract for financial assistance made available from the
 1-41 resiliency fund.

1-42 SECTION 3. Subchapter J, Chapter 17, Water Code, is amended
 1-43 by adding Section 17.913 to read as follows:

1-44 Sec. 17.913. GRANT STANDARDS. The law regarding uniform
 1-45 grant and contract management, Chapter 783, Government Code, does
 1-46 not apply to a contract under this subchapter.

1-47 SECTION 4. The changes in law made by this Act apply only to
 1-48 a contract entered into on or after the effective date of this Act.
 1-49 A contract entered into before the effective date of this Act is
 1-50 governed by the law in effect immediately before the effective date
 1-51 of this Act, and that law is continued in effect for that purpose.

1-52 SECTION 5. This Act takes effect September 1, 2021.
