11	(b) The board shall issue a license to practice medicine in
12	a location described by Subsection (e) to an applicant who:
13	(1) is licensed in good standing as a physician in
14	another state;
15	(2) is a veteran of the armed forces of the United
16	States who retired from or otherwise left military service not more
17	than one year before the application date for a license under this
18	section; and
19	(3) was, at the time of retiring from or leaving
20	military service:
21	(A) serving on active duty in this state; and
22	(B) authorized as a physician to treat persons
23	enlisted in the armed forces of the United States or veterans.
24	(c) An applicant for a license under this section is not

- Sec. 301.262. LICENSE FOR MILITARY VETERAN TO PRACTICE IN
- 24 CERTAIN AREAS. (a) In this section, "active duty" and "armed
- 25 forces of the United States" have the meanings assigned by Section
- 26 55.001.
- 27 (b) The board shall issue a license to practice nursing in a
