A BILL TO BE ENTITLED 1 AN ACT 2 relating to the content of an application for Medicaid. 3 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF TEXAS: SECTION 1. Section 32.025(g), Human Resources Code, 4 is 5 amended to read as follows: 6 The application form adopted under this section must (q) include: 7 for an applicant who is pregnant, a question 8 (1) 9 regarding whether the pregnancy is the woman's first gestational 10 pregnancy; and 11 (2) for all applicants, a question regarding the 12 applicant's preferences for being contacted, as follows: 13 "If you are determined eligible for benefits, your 14 managed care organization or health plan provider may contact you by telephone, text message, or e-mail about health care matters, 15 16 including reminders for appointments and information about immunizations or well check visits. All preferred methods of 17 contact listed on this application will be shared with your managed 18 care organization or health plan provider. 19 20 If your preferred method of contact about health 21 care matters is by electronic communication, including text message or e-mail, please be advised that while your managed care 22 23 organization or health plan provider is required to protect the security of that communication, because electronic communication 24

may not be encrypted there is still a risk of a security breach, 1 including the risk of confidential or private information being 2 intercepted by an unauthorized third party. 5 SECTION 4. This Act takes effect immediately if it receives 6 a vote of two-thirds of all the members elected to each house, as 7 provided by Section 39, Article III, Texas Constitution. If this 8 Act does not receive the vote necessary for immediate effect, this 9 Act takes effect September 1, 2021.
