7	(1) "Hospital" means a hospital licensed under this
8	chapter.
9	(2) "Qualifying official disaster order" means ar
10	order, proclamation, or other instrument issued by the governor,
11	another official of this state, or the governing body or an official
12	of a political subdivision of this state declaring a disaster that
13	has infectious disease as the basis for the declared disaster.
14	(3) "Qualifying period of disaster" means the period
15	of time the area in which a hospital is located is declared to be a
16	disaster area by a qualifying official disaster order.

- 18 disaster prohibit in-person visitation with a patient receiving

- 20 (c) Notwithstanding Subsection (b), a hospital may during a

- (1) restrict the number of visitors a patient
- 23 receiving care or treatment at the hospital may receive to not fewer
- 24 than one;

1	(2) require a visitor to the hospital to:
2	(A) complete a health screening before entering
3	the hospital; and
4	(B) wear personal protective equipment at all
5	times while visiting a patient at the hospital; and
6	(3) deny entry to a visitor who fails or refuses to:
7	(A) submit to or meet the requirements of a
8	health screening administered by the hospital; or
9	(B) wear personal protective equipment that
10	meets the hospital's infection control and safety requirements in
11	the manner prescribed by the hospital.
12	(d) A health screening administered by a hospital under this
13	section must be conducted in a manner that is consistent with:
14	(1) hospital policy; and
15	(2) if applicable, guidance or directives issued by
16	the commission, the Centers for Medicare and Medicaid Services, or
17	another agency with regulatory authority over the hospital.
18	(e) Notwithstanding any other law, a hospital is not subject
19	to civil or criminal liability or an administrative penalty if a
20	visitor contracts or spreads an infectious disease while on the
21	hospital's premises during a qualified period of disaster, except
22	where intentional misconduct or gross negligence by the hospital is
23	shown.
24	SECTION 2. This Act takes effect September 1, 2021.
