## A BILL TO BE ENTITLED

AN ACT

- 2 relating to the licensing and regulation of company representatives
- 3 for certain private security license holders; requiring an

- 5 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF TEXAS:
- 6 SECTION 1. Section 1702.002, Occupations Code, is amended
- 7 by amending Subdivision (5-c) and adding Subdivision (5-d) to read
- 8 as follows:

- 10 who is responsible for a company license holder's compliance with
- 11 this chapter.
- 12 <u>(5-d)</u> "Department" means the Department of Public
- 13 Safety of the State of Texas.
- 14 SECTION 2. Subchapter F, Chapter 1702, Occupations Code, is
- 15 amended by adding Sections 1702.1155 and 1702.126 to read as
- 16 follows:
- 17 Sec. 1702.1155. COMPANY REPRESENTATIVE LICENSE. (a) An
- 18 individual may not act as a company representative for a company
- 19 <u>license holder unless the individual is licensed under this section</u>
- 20 <u>as a company representative.</u>
- 21 (b) An application for a company representative license
- 22 under this section must be in the form prescribed by the department
- 23 and include:
- 24 (1) the full name and business address of the

- 1 applicant; and 2 (2) a statement as to whether the applicant: (A) is additionally applying for or holds a 3 4 company license; or 5 (B) is applying for the company representative 6 license to serve as the company representative for a company 7 license holder that is not the applicant. 8 (c) An applicant is eligible for a company representative license if the applicant has passed the licensing examination under 9 Section 1702.117. The applicant is not required to meet any 10 experience requirement for a company license under this subchapter. 11 12 Sec. 1702.126. DESIGNATION OF COMPANY REPRESENTATIVE. (a) 13 A company license holder shall: 14 (1) if the company license holder is an individual who 15 also holds a company representative license, designate that individual as the company representative for the company license 16 17 holder; or (2) if the company <u>license holder does not hold a</u> 18 19 company representative license, designate a company representative 20 license holder as the company representative for the company license holder. 21

- 3 SECTION 3. (a) The Public Safety Commission shall adopt
- 4 rules necessary to implement the changes in law made by this Act not
- 5 later than December 1, 2021. A person is not required to obtain a
- 6 license under Section 1702.1155, Occupations Code, as added by this
- 7 Act, to act as a company representative before January 1, 2022.
- 8 (b) Not later than January 1, 2022, a company license holder
- 9 shall designate a company representative in accordance with Section
- 10 1702.126, Occupations Code, as added by this Act.
- 11 SECTION 4. This Act takes effect September 1, 2021.
