## A BILL TO BE ENTITLED 1 AN ACT 2 relating to the regulation of coin-operated machines. 3 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF TEXAS: 4 SECTION 1. Section 2153.051, Occupations Code, is amended 5 by adding Subsections (c), (d), and (e) to read as follows: 6 (c) Notwithstanding any other provision of this chapter, the comptroller shall disclose confidential information, including 7 information included in a license or registration certificate 8 9 application, to a law enforcement agency that submits to the comptroller a written request for the information in connection 10 with an investigation the agency is conducting. A peace officer is 11 an appropriate official for purposes of the disclosure of 12 information under Subsection (b)(5). 13 14 (d) Information disclosed to a law enforcement agency in accordance with Subsection (c) remains confidential information 15 16 under Section 2153.102, and the agency may use the information only for purposes of the investigation, and any related prosecution, for 17 which the agency submitted the written request. 18 (e) In this section, "law enforcement agency" means an 19 agency of this state or an agency of a political subdivision of this 20 state authorized by law to employ peace officers. 21 SECTION 2. Section 2153.305(a), Occupations Code, 22 is 23 amended to read as follows: 24 (a) The comptroller may refuse to issue or renew or may

suspend or revoke a license or registration certificate, or a tax
permit or license issued by the comptroller to the applicant or
registration certificate holder for a different tax or activity
administered by the comptroller, if:

5 (1) the applicant or license or registration 6 certificate holder violates this chapter or a rule adopted under 7 this chapter;

8 (2) the applicant or license or registration 9 certificate holder fails to answer a question or makes a false 10 statement in, or in connection with, an application;

(3) the applicant or license or registration certificate holder extends or lends credit without notifying the commissioner of the person's intent to extend or lend credit [as required by Section 2153.253];

15 (4) the applicant or license or registration 16 certificate holder uses coercion to accomplish a purpose or engage 17 in conduct regulated by the comptroller; or

(5) the applicant or 18 or license registration certificate holder enters into a contract or agreement with the 19 owner of the location of a coin-operated machine and the contract or 20 agreement contains any kind of restriction relating to the location 21 owner's right to purchase, agree to purchase, or use a product, 22 23 commodity, or service that is not regulated under this chapter.

SECTION 3. This Act takes effect immediately if it receives a vote of two-thirds of all the members elected to each house, as provided by Section 39, Article III, Texas Constitution. If this Act does not receive the vote necessary for immediate effect, this
