4	BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF TEXAS:
5	SECTION 1. Section 21.202(a), Labor Code, is amended to
6	read as follows:
7	(a) A complaint under this subchapter must be filed not
8	later than the 180th day after the date the alleged unlawful
9	employment practice occurred. With respect to an allegation of
10	discrimination in payment of compensation in violation of this
11	chapter, an unlawful employment practice occurs each time:
12	(1) a discriminatory compensation decision or other
13	practice is adopted;
14	(2) an individual becomes subject to a discriminatory
15	compensation decision or other practice; or
16	(3) an individual is adversely affected by application
17	of a discriminatory compensation decision or other practice,
18	including each time wages affected wholly or partly by the decision
19	or other practice are paid.
20	SECTION 2. Section 21.258, Labor Code, is amended by
21	amending Subsection (c) and adding Subsections (d) and (e) to read
22	as follows:
23	(c) Except as otherwise provided by Subsection (d),
24	<u>liability</u> [ <del>Liability</del> ] under a back pay award may not accrue for a

date more than two years before the date a complaint is filed with
the commission.

Liability may accrue, and an aggrieved person may obtain 3 (d) relief as provided by this subchapter, including recovery of back 4 pay for up to two years preceding the date of filing the complaint, 5 if the unlawful employment practices that have occurred during the 6 7 period for filing a complaint are similar or related to unlawful employment practices with regard to discrimination in payment of 8 compensation that occurred outside the period for filing a 9 10 complaint.

11 (e) Interim earnings, workers' compensation benefits, and 12 unemployment compensation benefits received operate to reduce the 13 back pay otherwise allowable <u>under this section</u>.

14 SECTION 3. The changes in law made by this Act apply only to 15 a discriminatory compensation decision or other unlawful 16 employment practice with regard to discrimination in payment of 17 compensation made on or after the effective date of this Act.

18 SECTION 4. This Act takes effect immediately if it receives 19 a vote of two-thirds of all the members elected to each house, as 20 provided by Section 39, Article III, Texas Constitution. If this 21 Act does not receive the vote necessary for immediate effect, this 22 Act takes effect September 1, 2021.
