6	(b) Appointments to the board shall be made without regard
7	to the race, color, disability, sex, religion, age, or national
8	origin of the appointee.
9	Sec. 2310.221. Terms; Vacancy. (a) Members of the board
10	serve staggered six-year terms, with the terms of one or two members
11	expiring on the same date each odd-numbered year.
12	(b) If a vacancy occurs during a member's term, the
13	presiding officer of the commission, with the commission's
14	approval, shall appoint a replacement to fill the unexpired term.
15	Sec. 2310.222. Presiding Officer. The presiding officer of
16	the commission, with the commission's approval, shall designate one
17	member of the advisory board as presiding officer to serve in that
18	capacity for a one-year term.
19	Sec. 2310.223. Board Duties. The board may advise the
20	commission and department on:
21	(1) the adoption of appropriate standards for the
22	installation, maintenance, calibration, alteration, operation,
23	testing, and inspection of motor fuel dispensers, devices, and
24	<u>fuel;</u>
25	(2) education and curricula for applicants and licensees;
26	(2) the content of examinations;
27	(3) proposed rules and standards on technical issues

3 (4) other issues affecting motor fuel metering and quality.
4 (b) The advisory board shall meet at the call of the
5 executive director or the presiding officer of the commission.

6 SECTION 2. No later than December 1, 2021, the commission 7 shall appoint members to the Motor Fuel Metering and Quality 8 Advisory Board.

9 SECTION 3. This Act takes effect immediately if it receives 10 a vote of two-thirds of all the members elected to each house, as 11 provided by Section 39, Article III, Texas Constitution. If this 12 Act does not receive the vote necessary for immediate effect, the 13 Act takes effect September 1, 2021.
