BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF TEXAS:

SECTION 1. Title 2, Health and Safety Code, is amended by adding Subtitle J to read as follows:

SUBTITLE J. PAYMENT FOR HEALTH CARE SERVICES AND SUPPLIES

CHAPTER 185. HEALTH CARE BILLING

Sec. 185.001. DEFINITIONS. In this chapter:

(1) "Debt collection" has the meaning assigned by

Finance Code. Section 392 .001,

"Health care provider" means an individual facility licensed, certified, or otherwise authorized to administer health care services or supplies in this state in the ordinary course of business or professional practice, including a

physician or a hospital.

(3) "Health care service" means a service provided to an individual by a health care provider to diagnose, prevent, treat, alleviate, cure, or heal a human health condition, illness, injury, or disease.

Sec. 185.002. ITEMIZED BILL REQUIRED. (a) A health care provider who requests payment from a patient for a health care service or related supply provided to the patient shall submit with the request a written, itemized bill of charges for all health care services and supplies provided to the patient during the patient's visit to the provider.

The itemized bill must include:
(1) the amount the health care provider agrees full payment for each health care service and supply accept as provided to the patient by that provider;

(2) a plain language description of each discrete

(3) if reimbursement is sought from a third party, 1-52 1-53 billing code submitted to the third party and the amounts billed to and paid by that third party. 1-54

(c) A health care provider may issue the itemized bill electronically, including through a patient portal provider's Internet website.
