5	BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF TEXAS:
6	SECTION 1. Article 18A.101, Code of Criminal Procedure, is

Title 5, Penal Code, is amended by adding Chapter 23 to read as follows: 10 11 CHAPTER 23. MASS VIOLENCE Sec. 23.01. MASS VIOLENCE. (a) A person commits an offense 12 if, during the same criminal transaction or pursuant to the same 13 scheme or course of conduct: 14 15 (1) the person uses a deadly weapon to commit 16 aggravated assault as defined under Section 22.02(a)(1) or to commit murder as defined under Section 19.02(b)(1); and 17 18 (2) four or more people suffer serious bodily injury or death as a result of the person's conduct. 19 20 (b) An offense under Subsection (a) is a capital felony, except that the offense under Subsection (a) is a felony of the 21 first degree if the offense resulted only in serious bodily injury. 22 (c) A person commits an offense if the person intentionally 23 or knowingly takes two or more substantial steps of preparation 24 25 that, in concert, would cause a reasonable person to believe that the person intends to commit an offense under Subsection (a). 26 27 (d) An offense under Subsection (c) is a felony of the third

(a) A person 2 commits an offense if the person intentionally or knowingly conveys 3 4 information to another person: 5 (1) that the actor knows to be false or misleading; 6 (2) in a manner that would cause a reasonable person to 7 believe that the information is true; and 8 (3) that indicates that an offense under Section 9 23.01(a) has been or will be committed. 10 (b) An offense under this section is a state jail felony. (d) An offense under this section is a felony of the third 3 degree, except that the offense is a felony of the second degree if 4 the offense or the attempt to commit an offense under Section 5 23.01(a) resulted in the serious bodily injury or death of a person. 6 7 Sec. 23.04. APPLICABILITY OF OTHER LAW. If conduct that constitutes an offense under this chapter also constitutes an 8 offense under other law, the actor may be prosecuted under the 9 applicable section of this chapter, the other law, or both. 10

11 SECTION 4. Section 38.05, Penal Code, is amended by 12 amending Subsection (c) and adding Subsection (e) to read as 13 follows:

15 (e), an offense under this section is a Class A misdemeanor.

PROSECUTION OF MASS VIOLENCE GRANT PROGRAM. 4 (a) In this section: 5 (1) "Criminal justice division" means the criminal justice division established under Section 772.006. 6 7 (2) "Mass violence" means any offense for which, during the same criminal transaction or pursuant to the same scheme 8 9 or course of conduct, a person uses a deadly weapon to commit aggravated assault as defined under Section 22.02(a)(1) or to 10 11 commit murder as defined under Section 19.02(b)(1), Penal Code, and four or more people suffer serious bodily injury or death as a 12 13 result of the person's conduct (3) "Eligible prosecuting attorney" means a district 14 attorney, criminal district attorney, or county attorney with 15 felony criminal jurisdiction. 16 17 (4) "Serious Bodily injury" has the meaning assigned by Section 1.07, Penal Code. 18 (b) The criminal justice division shall establish and 19 20 administer a grant program through which counties and judicial districts that operate an eligible prosecuting attorney's office 21 may apply for a grant to support the prosecution of mass violence in 22 a county or counties under the jurisdiction of the attorney. 23 24 (c) The criminal justice division shall establish: 25 (1) additional eligibility criteria for grant 26 applicants; 27 (2) grant application procedures;

6	(d) The criminal justice division shall include in the
7	biennial report required by Section 772.006(a)(9) a detailed
8	reporting of the results and performance of the grant program

9 administered under this section.

10 SECTION 6. The changes in law made by this Act apply only to 11 an offense committed on or after the effective date of this Act. An 12 offense committed before the effective date of this Act is governed 13 by the law in effect on the date the offense was committed, and the 14 former law is continued in effect for that purpose. For purposes of 15 this section, an offense was committed before the effective date of 16 this Act if any element of the offense occurred before that date.

SECTION 7. This Act takes effect immediately if it receives a vote of two-thirds of all the members elected to each house, as provided by Section 39, Article III, Texas Constitution. If this Act does not receive the vote necessary for immediate effect, this Act takes effect September 1, 2021.
