## A BILL TO BE ENTITLED

1 AN ACT 2 relating to the membership of the Public Utility Commission of 3 Texas. Δ BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF TEXAS: SECTION 1. Section 12.051(a), Utilities Code, is amended to 5 6 read as follows: (a) 7 The commission is composed of five [three] 8 commissioners appointed by the governor with the advice and consent of the senate. 9 SECTION 2. Section 12.053, Utilities Code, is amended by 10 amending Subsections (a) and (b) and adding Subsection (a-1) to 11 12 read as follows: 13 (a) To be eligible for appointment, a commissioner must: 14 be a qualified voter; (1) 15 (2) be a citizen of the United States; be a resident of this state; 16 (3) 17 (4) be a competent and experienced administrator; [(4) be well informed and qualified in the field of 18 public utilities and utility regulation; and 19 (5) have at least five years of experience: 20 21 (A) in the administration of business or 22 government or 23 (B) as a practicing attorney [or] certified public accountant, or professional engineer. 24

1 <u>(a-1) At least two commissioners must be well informed and</u> 2 <u>qualified in the field of public utilities and utility regulation.</u> 3 (b) A person is not eligible for appointment as a

4 commissioner if the person:
5 (1) at any time during the <u>one year</u> [two years]

6 preceding appointment:

7 (A) personally served as an officer, director,
8 owner, employee, partner, or legal representative of a public
9 utility regulated by the commission or of an affiliate or direct
10 competitor of a public utility regulated by the commission; [<del>or</del>]

(B) owned or controlled, directly or indirectly, more than a 10 percent interest in a public utility regulated by the commission or in an affiliate or direct competitor of a public utility regulated by the commission; or

15 (C) served as an executive officer listed under 16 Section 1, Article IV, Texas Constitution, other than the secretary 17 of state, or a member of the legislature; or

18 (2) is not qualified to serve under Section 12.151,
19 12.152, or 12.153.

20 SECTION 3. (a) Not later than the 30th day after the 21 effective date of this Act, the governor shall appoint a person to 22 the Public Utility Commission of Texas to serve as the presiding 23 officer of the commission in accordance with Section 12.053, 24 Utilities Code, as amended by this Act.

(b) In making appointments of commissioners to the Public
Utility Commission of Texas under Section 12.051, Utilities Code,
as amended by this Act, the governor shall assign staggered terms to

1 the commissioners appointed to fill vacancies and to the 2 commissioners appointed to new positions to ensure that the 3 requirements of Section 30a, Article XVI, Texas Constitution, are 4 met.

5 SECTION 4. This Act takes effect immediately if it receives 6 a vote of two-thirds of all the members elected to each house, as 7 provided by Section 39, Article III, Texas Constitution. If this 8 Act does not receive the vote necessary for immediate effect, this 9 Act takes effect September 1, 2021.
