| 8 | Sec. 1232.1026. ISSUANCE OF BONDS FOR TEXAS BULLION |
| 9 | DEPOSITORY BUILDINGS. (a) The board may issue and sell bonds in |
| 10 | the name of the authority to finance the acquisition or |
| 11 | construction of buildings to be used to operate the Texas Bullion |
| 12 | Depository, including the acquisition of real property for that |
| 13 | purpose. |
| 14 | (b) The comptroller shall accomplish its statutory |
| 15 | authority as if the property or building acquired or constructed |
| 16 | under this section were funded by legislative appropriation. The |
| 17 | board and the comptroller shall adopt a memorandum of understanding |
| 18 | that defines the division of authority between the board and |
| 19 | comptroller regarding the property or building. |
| 20 | (c) On completion of the acquisition of property or |
| 21 | construction of a building, the comptroller shall contract with the |
| 22 | authority to purchase the property or building from the authority |
| 23 | under a lease-to-purchase agreement. |

| 4 | comptroller, by purchase, lease, donation, or other means, may |
| 5 | acquire real property necessary for one or more buildings to |
| 6 | operate the depository. |
| 7 | Sec. 2116.072. PURCHASE OF BUILDING SUBJECT TO EXISTING |
| 8 | LEASES. The comptroller may: |
| 9 | (1) acquire a building that is subject to a lease by a |
| 10 | private tenant and may continue or renew a lease for the building if |
| 11 | the comptroller determines that doing so is advantageous to this |

1 comptroller shall obtain in the name of this state title to any real 2 property acquired or building constructed under this subchapter and

3 retain control of that real property at all times.

<u>Sec. 2116.075. BORROWING MONEY; ISSUING AND SELLING BONDS.</u>
(a) The comptroller may borrow money in the amount and under the
circumstances authorized by the legislature and may request the
<u>Texas Public Finance Authority, on behalf of the comptroller, to</u>
issue and sell bonds to acquire real property or construct a
<u>building to operate the depository.</u>

10 (b) The Texas Public Finance Authority may sell the bonds 11 for the purposes of Subsection (a) in any manner the authority 12 determines to be in the best interest of the comptroller, except 13 that the authority may not sell a bond that has not been approved by 14 the attorney general and registered with the comptroller.

15 SECTION 3. This Act takes effect immediately if it receives 16 a vote of two-thirds of all the members elected to each house, as 17 provided by Section 39, Article III, Texas Constitution. If this 18 Act does not receive the vote necessary for immediate effect, this 19 Act takes effect September 1, 2021.
