1-15 SENATE CONCURRENT RESOLUTION

1-16 WHEREAS, The city of San Angelo has become a vibrant showcase
1-17 for the visual arts, featuring a variety of engaging public
1-18 artworks as well as a diverse mix of outstanding museums,
1-19 galleries, and studios; and

1-20 WHEREAS, The hub of the city's arts community is a 200-acre
1-21 cultural district along the south bank of the Concho River, which is
1-22 anchored by the San Angelo Museum of Fine Arts; the recipient of a
1-23 number of prestigious national awards, SAMFA includes an extensive
1-24 permanent collection and also serves as the headquarters of the
1-25 Center for the Advancement and Study of Early Texas Art; in
1-26 addition, the museum sponsors an arts education program that draws
1-27 over 33,000 children each year, and it hosts several prominent arts
1-28 events: the San Angelo National Ceramic Competition,
1-29 EnPleinAirTEXAS, and the Richard and Pam Salmon Sculpture
1-30 Competition, which brings large-scale works to Sunken Garden Park;
1-31 other attractions in the cultural district include the Fort Concho
1-32 National Historic Landmark, which has served as the site of the
1-33 American Plains Artists juried exhibition; and

1-34 WHEREAS, San Angelo also boasts the Pop Art Open Air Museum,
1-35 which features free public works by Texas artists; the display is
1-36 organized by the Art in Uncommon Places organization, and that
1-37 group has partnered with Downtown San Angelo, Inc., to create
1-38 another outdoor site, Paintbrush Alley, to exhibit paintings
1-39 inspired by Texas culture and the classic motion picture *Giant*;
1-40 other public art projects include some 100 colorful sheep
1-41 sculptures found throughout town that have been painted by local
1-42 artists and the Historic Murals of San Angelo, which depict iconic
1-43 scenes related to the area's past; moreover, the city is one of only
1-44 three in Texas to have a permanent "Don't Mess with Texas" mural;
1-45 and

1-46 WHEREAS, The dynamic arts community in San Angelo encompasses
1-47 nearly three dozen galleries and studios; more than 250 sculptures
1-48 and statues are displayed at local businesses, schools, parks, and
1-49 other locations, and the city is the site of such popular events as
1-50 the Chicken Farm Art Center Open House, which has taken place each
1-51 year for nearly a half century; and

1-52 WHEREAS, San Angelo's art scene has drawn statewide and
1-53 national attention from media outlets, including *Western Art &*
1-54 *Architecture, Texas Highways,* and *True West* magazines; a further
1-55 tribute to the city's cultural riches came in 2019, when the
1-56 European Union ambassador to the United States selected 32 pieces
1-57 of art on loan from the San Angelo Museum of Fine Arts for display in
1-58 his home in Washington, D.C.; and

1-59 WHEREAS, The city of San Angelo has become an epicenter for
1-60 art lovers from across the state and around the nation, and its
1-61 unique concentration of talented artists, imaginative exhibits,

2-1 and an enthusiastic arts community make it truly deserving of
2-2 special recognition; now, therefore, be it

2-3 RESOLVED, That the 87th Legislature of the State of Texas
2-4 hereby designate the city of San Angelo as the official Visual Arts
2-5 Capital of Texas; and, be it further

2-6 RESOLVED, That, in accordance with the provisions of Section
2-7 [391.003](#)(e), Government Code, this designation remain in effect
2-8 until the 10th anniversary of the date this resolution is finally
2-9 passed by the legislature.
