2               WHEREAS, Eddie Garner Clement, an esteemed member of the  
3 Paris, Texas, community and a friend to many, passed away on January  
4 19, 2021, at the age of 55; and

5               WHEREAS, The son of Ted Garner Clement and Carol Ann Clement,  
6 Eddie Clement was born on August 7, 1965, in Dallas and grew up in  
7 Duncanville with a sister, Eva; he completed his bachelor of  
8 business administration degree in management at The University of  
9 Texas at Arlington, where he made lasting friendships as a member of  
10 Phi Delta Theta and discovered his love of music and entertainment;  
11 through the years, he delighted in acting as DJ for any event and  
12 always knew exactly what to play to make everyone happy; and

13               WHEREAS, Mr. Clement embarked on a career with the Sonic  
14 Drive-In chain, and he was a member of the board of Lamar National  
15 Bank; giving generously of his time and expertise, he also served on  
16 the boards of numerous civic organizations, among them Denver  
17 Pyle's Children's Charities, the Lamar County Chamber of Commerce,  
18 the Lamar County Chapter of the American Red Cross, and the Boys &  
19 Girls Club of Paris, which included him on its Wall of Honor; he was  
20 a valued congregant of Our Lady of Victory Catholic Church and a  
21 third-degree knight in the Knights of Columbus; and

22               WHEREAS, Devoted to his family, Mr. Clement shared a  
23 fulfilling marriage of 26 years with his wife, Monica Homer  
24 Clement, and he was the proud father of three children, Avery,

1 Mollie, and Adam; in his free time, he liked a good round of golf,  
2 but above all, he enjoyed helping others in any way he could; and

3       WHEREAS, Eddie Clement lived a caring and purposeful life,  
4 and although he is deeply missed by those he left behind, they will  
5 forever cherish their memories of his warmth and kindness; now,  
6 therefore, be it

7       RESOLVED, That the 87th Legislature of the State of Texas  
8 hereby pay tribute to the life of Eddie Garner Clement and extend  
9 sincere condolences to all who mourn his passing; and, be it further
