SENATE JOINT RESOLUTION 1 proposing a constitutional amendment changing the eligibility 2 3 requirements for certain judicial offices. Δ BE IT RESOLVED BY THE LEGISLATURE OF THE STATE OF TEXAS: SECTION 1. Section 2(b), Article V, Texas Constitution, is 5 6 amended to read as follows: 7 No person shall be eligible to serve in the office of 8 Chief Justice or Justice of the Supreme Court unless the person: 9 (1) is licensed to practice law in the State of Texas; [this state and] is, at the time of election, a 10 (2) citizen of the United States and a resident of the State of Texas; 11 [this state, and] has attained the 12 (3) 13 thirty-five years; [ rand] has been either: 14 (4)15 (A) a practicing lawyer licensed in the State of Texas for at least ten years;  $[\tau]$  or 16 17 (B) a practicing lawyer licensed in the State of Texas and judge of a state court or county court established by the 18 Legislature by statute for a combined total of [court of record 19 together] at least ten years; and 20 (5) during the time required by Subdivision (4) of 21 22 this subsection has not had the person's license to practice law revoked, suspended, or subject to a probated suspension. 23

SECTION 2. Section 7, Article V, Texas Constitution,

- 2 Sec. 7. (a) The State shall be divided into judicial
- 3 districts, with each district having one or more Judges as may be
- 4 provided by law or by this Constitution.
- 5 (b) Each district judge shall be elected by the qualified

- 7 election as a district judge, a person must:
- 8  $\underline{\text{(1)}}$  [and shall] be a citizen of the United States and  $\underline{a}$
- 9 resident of this State;
- 10 (2) be[, who is] licensed to practice law in this

- 12 (3) have [and has] been a practicing lawyer or a Judge
- 13 of a Court in this State, or both combined, for eight [four (4)]
- 14 years next preceding the judge's [his] election, during which time
- 15 the judge's license to practice law has not been revoked,
- 16 suspended, or subject to a probated suspension;
- 17 (4) have [who has] resided in the district in which the
- 18 <u>judge</u> [he] was elected for two [ $\frac{(2)}{(2)}$ ] years next preceding the [his]

- 21 the judge's [his] term of office.
- 22 <u>(c) A district judge shall [and]</u> hold the [his] office for
- 23 the  $\underline{\text{term}}$  [ $\underline{\text{period}}$ ] of four [ $\underline{\text{(4)}}$ ] years[ $\underline{\text{T}}$ ] and [ $\underline{\text{who}}$ ] shall receive for
- 24 the judge's [his] services an annual salary to be fixed by the

- 26 (d) A District [The] Court shall conduct its proceedings at
- 27 the county seat of the county in which the case is pending, except

- 1 as otherwise provided by law. The Court [He] shall hold the regular

- 7 <u>(e)</u> The Legislature shall also provide for the holding of
- 8 District Court when the Judge thereof is absent, or is from any
- 9 cause disabled or disqualified from presiding.
- 10 SECTION 3. The following temporary provision is added to
- 11 the Texas Constitution:
- 12 TEMPORARY PROVISION. (a) This temporary provision applies
- 13 to the constitutional amendment proposed by the 87th Legislature,
- 14 Regular Session, 2021, changing the eligibility requirements for a
- 15 justice of the supreme court, a judge of the court of criminal
- 16 appeals, a justice of a court of appeals, and a district judge.
- 17 (b) The amendment to Section 2(b), Article V, of this
- 18 constitution takes effect January 1, 2022, and applies only to a
- 19 chief justice or other justice of the supreme court, a presiding
- 20 judge or other judge of the court of criminal appeals, or a chief
- 21 justice or other justice of a court of appeals who is first elected
- 22 for a term that begins on or after January 1, 2025, or who is
- 23 <u>appointed on or after that date.</u>
- 24 <u>(c) The amendment to Section 7, Article V, of this</u>
- 25 constitution takes effect January 1, 2022, and applies only to a
- 26 district judge who is first elected for a term that begins on or
- 27 after January 1, 2025, or who is appointed on or after that date.
