Dear Honorable Committee Members:

I am against HB 1757 and urge you to vote against this bill. I am testifying on behalf of myself.

It would be great to address police accountability and transparency at the state level; however, HB 1757 does not promote these important goals. Instead, it discriminatorily targets specific protected conduct that is loathed by the police lobby. It's morally outrageous that innocent reporters will be accosted so that bad cops can keep their jobs.

It is already legal to film the police in Texas. It is an inalienable right granted by our creator and protected by the United States Constitution. In 2017, the U.S. 5th Circuit Court of Appeals confirmed that the people have a 1st Amendment right to video record the police in the case Turner v. Driver.

The proposed law does not establish any new right or privilege of the people. But it does empower bad cops to violate the rights of people who film them: they will "order" individuals to "positions" and "proximity" that prohibits news gathering.

I am an independent journalist who reports about local government and police. I document dozens of police scenes each month. Unfortunately, many officers, even in 2021, attempt to block the public from observing (i.e., seeing and hearing what is happening, in detail) the official activities of the police. Police officers from jurisdictions across the state use the following line when attempting to violate the right to film the police: "You can film all you want, but..." What comes after "but" is almost always a directive that blocks me from actually documenting the police activity.

It is very concerning to me that the police strategy of blocking recording (while purporting to allow it) may now become state statute in Texas.

It is very concerning to me that I may have to choose between exercising my rights or going to jail on unconstitutional charges. It is concerning that I may not be able to do my job.

Bystander videos of police activity have created positive change in Texas in recent years. And I can understand why certain political groups might try to block the free flow of information. But the political agenda of labor organizations should not be allowed to obstruct the general public's desire for reform.

I routinely video record law enforcement in El Paso County Texas, and place those video recordings onto my small YouTube Channel (THE HORIZON CITY NEWS SERVICE).

I strongly object to any law that would restrict and/or interfere with my video recording of police, or give law enforcement the arbitrary authority to dictate where I can or can not physically stand, when I video record law enforcement and/or other government employees/officials.

"Officer Safety" is not a law, and is often declared by law enforcement members who want to arbitrarily set a "safe proximity" around themselves, and/or law enforcement vehicles, and/or criminal suspects, and/or detained vehicles.

Texas Penal Code 38.15 does not dictate a "set distance" for video recording law enforcement.

Law enforcement needs to be spontaneously video recorded, and at the closest distance where audio and video can be gathered without interfering with public duties.

Any new Texas law that would attempt to regulate video recording of law enforcement, would instantly create a "chilling effect" upon almost anyone that would consider video recording Texas law enforcement.

I am against HB 1757 and request that you vote against this bill. I am testifying on behalf of myself.

I believe that it would be great to address the police accountability and transparency at the state level. HB 1757 does not promote these important goals but rather it discriminatorily targets specific protected conduct that the police lobby loath. I find it not just outrageous, but morally outrageous that innocent reporters will be increasingly accosted so that the bad cops can keep doing their bad behavior and keep their jobs.

It is currently legal to film the police in Texas. It is one of the inalienable rights granted by our Creator and protected by the United States Constitution. The U.S. 5th Circuit Court of Appeals confirmed that the people have a 1st Amendment right to video the police in the case of Turner versus Driver in 2017.

This proposed law in no way establishes any new rights or privileges of the people, rather it does give more power to corrupt police to violate the rights of citizens who are filming them. These bad police will order individuals to positions, and proximities that prohibit news gathering and will enable police to hide their bad behavior.

Currently officers are trying to block the public from observing or videoing the official activities of the police. Police officers are using directives such as, "You can video all you want, BUT..." The directive police give after the "but" is almost always a position that blocks the actual documenting of the activities of the police.

It is concerning that the strategy of blocking the recording while seeming to allow it may now become a state statute in Texas. I am very concerned that the police strategy of blocking the recording by reporters and journalist will make them have to choose between exercising their rights or going to jail on unconstitutional charges. This is concerning to me in that all future reports about situations that involve police will be one sided by police unions.

Citizen videos of police activity has created positive changes in Texas over the years. I understand that certain political groups will always try to block the free flow of information.
