The way Chapter 313 is structured it is always a bad deal for the locality and for the State. I understand that it is often necessary to offer corporations an incentive to locate to our State, but the idea is usually the new corporation will increase employment and the new employees will generate enough tax revenue to make up for the tax deferment being offered. The key here is NEW CORPORATIONS not companies already committed to our State and that are here to extract minerals they can't get anywhere else.

However, these deals have to be looked at very carefully, and school boards are not qualified to analyze complicated tax issues. For example, Micron Technology is applying for hundreds of millions of dollars in tax breaks for a massive program over 20 plus years for which they will only create 80 jobs – and not even high paying jobs! But if you look closely at why they want to build here it is that Texas offers the lowest rates on electricity, which this chip manufacturer depends on that cheap electricity.

Again, I understand the reasoning behind offering tax breaks to lure business to Texas. But Chapter 313 is so bad it needs to be killed and buried with no chance of resuscitation and be replaced with a state wide program that is administered out of Austin with competent staff that can see and understand all of the intricacies of these deals and can penalize those corporations that fail to fulfill their part of the deal. Most of the corporations that apply for Chapter 313 are already in Texas: Chevron, Exxon Mobil, Phillips 66, Occidental Petroleum, Texas Instruments, Samsung and Dow Chemical. They locate here because of qualified workers, education, infrastructure, and our abundant natural resources (oil, gas, coastline, sun, wind). This year, there has been a record number of Chapter 313 applications, including from corporations whose facilities won't open until 2040 or, like Samsung, aren't even sure how the welfare will be used. In 2015, Greg Abbott vetoed an expansion of Chapter 313, citing the program's poor cost per job as the reason for his veto. Senator Bettencourt says the jobs provisions of any such program should be "ironclad." But the last time an application was rejected was in 2016 and only 2 agreements have been abrogated for corporate performance failure. The current Chapter 313 has a very low threshold for access. The applicant only needs to provide twenty-five jobs. That is an insufficient number for the benefit conferred. There should be a reasonable relationship on the cost to the State on a per job basis. It makes no sense to cost the State several hundred thousand dollars for each job created.

The purpose of economic development should be to attract new businesses to Texas, not to provide an incentive to a corporation that is already here.

By giving the tax abatement, the corporation should not be allowed to depreciate the property so that very little tax benefit remains at the end of the abatement period, especially if the property would have substantial value if it were sold.

There should be substantial clawback provisions if the corporation does not meet the target it agreed to.

Only a small percentage of school districts benefit from this economic development program. The State needs to design any new public school economic development tax abatement program so that it does not take away revenue from the statewide needs of all public schools. There should also be restrictions on payments in lieu of taxes that a school district can receive from the corporation for entering into the tax abatement agreement.

Any future economic development legislation for public schools should be carefully drafted to ensure that Texas does receive a substantial economic benefit that would not have otherwise occurred. Granting tax abatements to corporations who would have expanded anyway does not serve this purpose.

As a member of the Texas Industrial Areas Foundation and its Houston affiliate, I am writing in opposition to the renewal of the Chapter 313 tax abatement program. There are at least 6 reasons to oppose renewal of the program

1. In past years, the program has costs Texas K-12 schools on average \$1B a year in annual funding. For the last year of the program at least 450 individual 313 applications have been filed with the potential to cost K-12 schools \$10-12B annually in school funding.

2. No such tax abatements are offered to small and medium sized businesses that expand or re-locate to Texas. Yet these smaller businesses often bring more jobs to their communities than the large corporations do.

3. Individual families must pay increased property taxes to make up for the abatements given to big businesses.

4. There is no evidence that companies receiving these abatements would not have relocated to Texas in their absence. In fact, a program designed to help companies relocate to Texas is abused; it is now largely used to help companies in Texas to "relocate and expand."

5. There is no accountability for this program. Not state agency - not even the Legislature itself - can impose a cap on the cost of abatements nor can they make determinations on individual projects or set priorities for the program. In effect, Chapter 313 allows big business interests an unlimited "draw" on the State treasury.

6. The program is rife with abuse and the potential for corruption. School districts that educate 5% of our children are allowed to grant tax abatements (with a guarantee that the State will make them whole), to the detriment of ISD's that educate 95% of our children. Moreover, districts that grant abatements are allowed to receive "pilot payments" or "donations" from corporations receiving the abatements. These "donations" go to ISDs non-profit foundations with no controls or reporting required on uses for these funds. Moreover, consultants receive huge fees for arranging these abatements as well.

My name is Stewart McGregor and I am the Executive Director for the Kaufman, TX Economic Development Corporation. I am

also on the Board of Directors for the Texas Economic Development Council (TEDC) as well as a member of the TEDC Legislative Committee. As an economic development professional in the nation's fastest growing county, I can attest to the importance of reviving a program in the spirit of Chapter 313. Texas has been on a major "winning streak" for the last decade with capital intensive projects and high wage jobs. The program has been so successful that surrounding states have created similar programs to make themselves more competitive. Kansas and Oklahoma both created an incentive to target projects of similar scale as Chapter 313 targeted. This led to a win in Kansas for a Panasonic battery manufacturing plant (which will be a major supplier to Tesla). With Texas having one of the highest property tax burdens in the nation, we can fall out of deals to states with lower ad valorem rates. I understand the concerns regarding renewable energy and the cottage industry of consultants and am open as an economic development professional to the Legislature making adjustments to the program to enhance reasonable transparency measures and tweak qualifying industries and job creation requirements.

Most Chapter 313 projects locate on properties that are ag-exempt, such as Tesla. These large parcels of land are typically valued on the tax rolls in the 4-low 5 digit range. When you place a \$1 Billion facility on the rolls, it shifts the funding away from the state and onto the local tax rolls since it adds M&O value up to the limitation amount allowed by that ISDs category. (i.e., a 200 acre ag-exempt property valued at \$10,000 lands new value of \$500 million on it. At a value limitation of \$80 million, the local ISD receives M&O revenue off of \$80 million allowing the state to shift its financial aid away from the local ISD). Therefore, the Legislature may look at creating a new program designed for projects locating specifically on ag-exempt property. This type of impact also enhances the other local taxing entities valuations which compresses the amount by which the other taxing authorities can assess in local property tax rates.

This past year I have witnessed a significant amount of capital intensive projects looking to locate in Texas. Many of these projects are looking because they know 313 expires at the end of this year. Following the expiration of 313s, Texas may not know just how many projects are lost because we aren't even considered due to not having a program of this type in place. It is my request you work with industry, tax experts and economic development professionals in creating a new program that will continue to allow Texas to compete for high wage, quality jobs that drive additional revenue for the state and helps lower the property tax burden on homeowners. Currently, wind and solar project substantially decline in value from the day they are built. In Wharton Co alone, we will be loosing approximately 30,000 acres top producing Agriculture acres due to solar and wind in the 2022-2023 year. With many more projects on the line. For example, we own an Agriculture Aviation Service, which has been in service since the 1940s. Currently, a w 640 ft wind turbine is set to be constructed within 1 mile north of our airstrip. This will negatively impact us as a business and the way we serve our farmers and ranchers. Making some forms of aviation (such as carrying heavy loads of fertilizer for rice fields) now dangerous from our airstrip. The FAA exempts Part 137 from wind studies and Texas provides no form of protection at the local or state level. Our business will be negatively impacted by this project.

The only group getting any short term (false-positive) impact to the school system, which is often ran by super intendants not within the district and not concerned about the long term effects to the community. If you look at Nolan Co (often referred to as the wind capital of Texas) since the projects have moved in, the county population has declined! Doing the opposite of what the 313/312 program has intended to do.

One of our biggest concerns is big solar going on prime farmland (ie the Blackland Prairie is the most fertile soil in Texas). Once in solar, it will never go back to farming. We must look out for our future farmers and the ability to grow crops on such valuable farmland.

Let the solar companies compete just like any other business. They do not need the incentive to come to Texas - they are coming anyway. If they can't make it financially, then they shouldn't be here in the first place.

It hurts public education—every dollar of school property taxes that a corporation doesn't pay is a dollar that does not go to fund public schools—funds that could be used to increase the number of teachers and teacher pay; improve school safety and mental health for students. We need to end corporate tax breaks that use school property taxes in order to properly fund our schools.

Less local property tax revenue means more sales taxes are needed— Public schools in Texas are paid for by both local school property taxes and by State of Texas tax revenue—mostly sales tax. When corporations don't pay their fair share, the State has to use more sales tax revenue to fully fund public education. As a result, YOU are subsidizing tax breaks for Tesla Motors, Exxon Mobile, Samsung and other Fortune 500 companies.

Most tax breaks are not needed: Chapter 313 was created in 2001 to offer a school property tax break to encourage big businesses to relocate to Texas. Recent studies by Nate Jensen of University of Texas and other scholars indicate that that at least 80% of these companies would come to Texas without the tax breaks. Companies don't come to Texas because of tax breaks. They locate here because of qualified workers, education, infrastructure and our abundant natural resources (oil, gas, coastline, sun, wind). Some Corporations are like "Hogs at the Trough": Chapter 313 will end December 31, 2022. In a normal year, about 80 to 90 corporations ask for Chapter 313 tax breaks. In 2022, corporations have asked for over 400 tax breaks for projects that could cost us billions more in school property taxes each year. For example, Samsung is asking for 9 tax breaks for projects they may build through 2045. Chenier is asking for

tax breaks on liquified natural gas projects they may build in 2038 and 2042.

School districts which offer these deals get "contributions" from the corporations: About 5% of Texas school districts are granting these tax breaks. Corporations can pay school districts \$100 per student as an incentive (Payment in Lieu of Taxation) to accept these deals. Those 5% of school districts are getting as much as \$50 million each year in corporate payments while the 95% of school districts would be better off if the school property taxes they are forgiving were used to increase the per pupil funding of ALL Texas schools. These funds usually disappear into a school foundation where there are few reporting requirements or public oversight.

Corporations are not asked to do much for hundreds of millions in tax breaks: Chapter 313 only required that corporations commit to create 10 new jobs that pay 10% over the average wage in the area to qualify for a tax break. Most of these deals are costing over \$1 Million in property taxes for each promised job. There is little oversight by the Texas Comptroller for these commitments which a

I'm a professor at the University of Texas at Austin. I have published peer-reviewed research on Chapter 313 that found the majority of companies utilizing the program would have invested even without this incentive. Many of these companies had started building prior to receiving incentives. This concern was documented in the 2016 Senate Natural Resource and Economic Development Report (Charge 3).

Many features of Chapter 313 were highly problematic, including the almost automatic authorization of these incentives by school districts and the Comptroller. But the fundamental problem, in my opinion, is that these were largely incentives targeted at energy investments that have limited geographic options for investment. These companies are likely to invest in Texas even without 313 and thus 313 is a transfer of money from Texas taxpayers to large companies. You can try to "fix" the program with stronger wage standards, but this doesn't address the fundamental program. Many of these companies were coming even without Chapter 313.

The consequences of a program like Chapter 313 isn't only the unfairness of small businesses paying their full share of taxes while some very large investments receive incentives. The key is if many of these companies were coming even without incentives, Texas is losing badly needed tax revenues. These tax revenues could be used for services, or to reduce the tax burden on all taxpayers.

Proponents often claim that these programs are "free". Claims of a "free lunch" should always raise an alarm. Many states directly evaluate their incentive programs, asking this exact question and consistently find that these programs do not pay for themselves. To my knowledge, the state hasn't performed any evaluation of this program that was in existence for decades.

Chapter 313 wasn't reauthorized due to both Democrats and Republican concerns about the program. Hastily recreating a problematic incentive program would cost Texas taxpayers billions of dollars.

Invest in Infrastructure and Good Jobs, not Property Tax Relief that Hurts School Funding and Pits Communities against Each Other: End 313

During the 87th Legislative Support, there was not sufficient legislative support to continue the Chapter 313 program, which offers major cuts on school property taxes to certain power plants and manufacturing plants in return for promises of investments and jobs. While the program at times has been successful in promoting the development of renewable energy and certain manufacturing facilities, the Sierra Club is in favor of ending the program.

First, school finance is impacted. Even though the individual school district offering the tax break may benefit with a make whole payment and a donation from the individual enterprise, the state as a whole suffers as funding that would have supported all school districts is instead funneled to an individual school district. This is not equitable to the state and pits individual school districts – rural and suburban and urban - tax rich and tax poor – against one another.

Second, the rules surrounding Chapter 313 have largely removed the public voice. Information is difficult to find, notice is imperfect and by the time the public has a chance to voice their support, concerns or opposition, the decision is already precooked. If Texas were to continue 313 agreements, then much better public participation and notice rules must be enacted, as well as more robust investigation and accountability.

Third, the promised investment and jobs frequently has not materialized as promised in the initial applications, meaning the industry receives favorable tax treatment, but the community doesn't receive the benefits.

In addition, to attract these industries, local communities must frequently invest in local water, electric and transportation infrastructure that creates expenses for the local communities.

Finally, and most importantly, some of these industries come with externalities - water use, pollution and waste. Even as the industry is offered favorable tax treatment and at times a beneficial payment to the school district, local communities - often frontline environmental justice communities – are burdened with more pollution.

Speaking frankly, wind and solar companies will invest in West Texas because the resource is good, and LNG Companies and Refineries will invest along the coast because – it's a coast and Texas has gas and oil. It's not the tax breaks that attract them, it's the resources.

While Sierra Club supports ending the 313 Tax agreements, if they are continued we would support continuing them for all industry, including renewable energy and storage companies.

While Sierra Club supports ending the 313 Tax agreements, if they are continued we would support continuing them for all industry, including renewable energy and storage companies.

However, rather than tax breaks, we think it makes more sense for the state to invest in its future, which will attract more industry. First, invest in our schools, community colleges and universities to attract leading industries, including hydrogen, renewable, storage, high tech, pollution control equipment, electric vehicle manufacturers, geothermal technologies and heat pumps, and other industries representing the transition to a clean economy.

Second, utilize funding from the IIJA (Bipartisan Infrastructure Law) to make our electric grid more resilient through transmission upgrades, create hydrogen hubs, create multi-modal transportation – including a vast EV-charging infrastructure, and be a leader on low-carbon industry development. Funding to continue to develop our water infrastructure - again partially using funds from the IIJA – through the Texas Water Development Board. Supplemental funding from the state should also be used to invest in flood infrastructure funding, and community resiliency.

Third, prioritize worker training programs. We believe the state should use either state funds or take advantage of unique funding under the IIJA and recently approved IRA of 2022 to create unique programs that work for workers, especially those transitioning from traditional employment in the oil and gas industry, the coal industry and heavy manufacturing to new types of industry. Last legislative session, Rep. Gina Hinojosa and Senator "Chuy" Hinojosa introduced legislation (HB 3878 and SB 955) - Relating to economic development and workforce retraining opportunities in the transition to the use of clean energy sources - that would have created a worker transition training program and advisory committee. Investing in new industries and particularly workers could be beneficial to all Texans, and the IRA and IIJA also offer monies for worker transition programs.

Rather than offering carrots to attract industry, and pit industries and communities against one another, Texas should invest in the 21st century, and create a leading multi-modal transportation system, a resilient electric grid, sustainable water solution and worker training programs. Denuding our school funding is not helpful to anyone.

Dear Chairman Meyer and Committee Members:

Texas public schools depend on the finance system that is funded by both local tax revenue and state funding. In its ideal form, this allows for funding equity between high- and low-property wealth districts to equitably fund public education according to their students' needs and the capacity of the surrounding community, with additional support from the state. We have never reached that ideal for many reasons, and reinstituting Chapter 313 exemptions would only further strain state revenue streams for public schools. Texas's public schools educate students pre-K through 12th grade, prepare students to enter our workforce and participate in our society, and provide essential health, wellness and safety services to our communities. To fund Texas's public schools, which serve over 5.4 million students, large tax exemption programs such as those offered through Chapter 313 should remain expired.

Instead of considering tax cuts and exemptions, the state can support sustainable state revenue sources that are progressive in nature, such as reducing tax exemptions for businesses and eliminating property tax cuts to large commercial properties. This would capture the growing economic power of Texas to help fund the institutions and services we rely on, such as quality public schools.

Valley Interfaith opposes resurrecting any corporate incentive program which uses school property taxes. If the State of Texas feels it is necessary to create an incentive program, it should be a program that is that is in the budget, has clear qualifying criteria and benchmarks. Chapter 313 has proven to be a cash cow for a cottage industry of lawyers and school finance experts and big corporations who are planning to locate in Texas already.

We oppose any new program that essentially resurrects Chapter 313 because:

It's expensive—Corporations are now receiving over \$1 Billion in school property tax breaks every year through these deals. It hurts public education—every dollar of school property taxes that a corporation doesn't pay is a dollar that does not go to fund public schools—funds that could be used to increase the number of teachers and teacher pay; improve school safety and mental health for students. We need to end corporate tax breaks that use school property taxes in order to properly fund our schools. Less local property tax revenue means more sales taxes are needed— Public schools in Texas are paid for by both local school property taxes and by State of Texas tax revenue—mostly sales tax. When corporations don't pay their fair share, the State has to use more sales tax revenue to fully fund public education. As a result, YOU are subsidizing tax breaks for Tesla Motors, Exxon Mobile, Samsung and other Fortune 500 companies.

Most tax breaks are not needed: Chapter 313 was created in 2001 to offer a school property tax break to encourage big businesses to relocate to Texas. Recent studies by Nate Jensen of University of Texas and other scholars indicate that that at least 80% of these companies would come to Texas without the tax breaks. Companies don't come to Texas because of tax breaks. They locate here because of qualified workers, education, infrastructure and our abundant natural resources (oil, gas, coastline, sun, wind). Some Corporations are like "Hogs at the Trough": Chapter 313 will end December 31, 2022. In a normal year, about 80 to 90 corporations ask for Chapter 313 tax breaks. In 2022, corporations have asked for over 400 tax breaks for projects that could cost us billions more in school property taxes each year. For example, Samsung is asking for 9 tax breaks for projects they may build through 2045. Chenier is asking for tax breaks on liquified natural gas projects they may build in 2038 and 2042. School districts which offer these deals get "contributions" from the corporations: About 5% of Texas school districts are granting these tax breaks. Corporations can pay school districts \$100 per student as an incentive (Payment in Lieu of Taxation) to accept these deals. Those 5% of school districts are getting as much as \$30 million each year in corporate payments while the 95% of school districts would be better off if the school property taxes they are forgiving were used to increase the per pupil funding.

I am writing to oppose legislation to bring back Chapter 313. Chapter 313 is expensive --public schools are hurting for funds to increase the number of teachers and their pay, and to improve mental health services for students and school safety. Just to keep up with inflation, school districts need another \$1000 per child. Yet Chapter 313 transfers over \$1 Billion a year in school property tax breaks to private corporations.

The rationale is to encourage big businesses to come to Texas. This rationale must hold up to scrutiny--however studies out of the University of Texas and other studies show that 80% of the companies would come to Texas anyway. Of course they assert that they would not come otherwise, but we do not require them to show that they have a better offer in another state. This powerfully alters the cost-benefit ratio. Whether it is property taxes or sales taxes going to the schools, any unwarranted giveaway to private corporations hurts the bottom line of our schools. A rush of tax-break projects have been applied for in 2022: 400 as compared to usually about 80 or 90 of them. Some of them would lock in tax breaks though 2038 or even 2045. We should not burden our schools with this.

The benefits to employment is very thin: Corporations are only required to create 10 new jobs that pay 10% over the average pay in the area. Mostly, these jobs cost over \$1 million dollars each in lost property taxes. There are much more cost-effective ways to invest to create new, well-paying jobs. Another problem is that about 5% of school districts grant these breaks, and Corporations can pay school districts \$100 per student as an incentive to accept these deals. Those 5% of school districts are getting as much as \$30 million each year in corporate payments while the 95% of school districts would be better off if the school property taxes they are forgiving were used to increase the per pupil funding of ALL Texas schools. Those districts are getting as much as \$30 million each year in corporate payments. The other 95% of districts would be better off if the school property taxes were used to increase the per pupil funding across Texas.

The 313 scheme is much more cost-effective for corporations who would mostly come to Texas anyway. The cost of this should not fall on the backs of our students. I ask you to prioritize our public school system.

The Coalition of Texans with Disabilities (CTD) is a statewide, cross-disability advocacy organization with members in all legislative districts. People with disabilities are the demographic group generally considered to have the lowest income, highest unemployment rate, lowest ownership of a home or vehicle and are more likely to die prematurely, not from disability rather from substandard access to health care. Texas ranks 49th of the states in providing community services for its citizens with disabilities. First and foremost, we appreciate the opportunity for folks to submit written electronic public comments on this important matter. I am writing to you today, the House Ways & Means Committee, as the Advocacy Director of Commission Shift-- a statewide nonpartisan nonprofit-- to communicate our disapproval of the Chapter 313 program.

The effectiveness and need for the continuation of Chapter 313 has been put into question before, and rightfully so, as it has become a matter of who seeks to benefit from the tax cuts provided. Is it Texans? Our public schools? Or big corporations?

We are concerned about the way corporations like Occidental Petroleum are abusing tax abatements through Ch. 313 in Kleberg and Ector County for their carbon capture initiatives. Using programs such as Ch. 313 makes it so that these costly-- and not yet proven-- technologies like carbon capture & sequestration, ultimately fall on us as taxpayers to fund while corporations are the only ones that stand to gain.

Meanwhile, with no state income taxes, us Texans highly depend on these very property taxes to fund our public schools. If we allow Ch. 313 to continue (or a different version of the same program) we are making way for corporations like Oxy to get out of paying their fair share of taxes that are due to our schools with no guarantee that the communities these corporations are coming in to will stand to benefit from their ventures.

Furthermore, another major concern with the nature of Ch. 313 is how it allows companies to lowball their own valuations, making them responsible for a fraction of what school taxes they would actually pay if their appraisals were a true reflection of their property values. We have seen this play out in the 1PointFive (Oxy's subsidiary) applications where initial limited values are listed at \$100 million, but then subsequent applications would have them pay out at a value of \$30 million, some even as low as \$5 million.

The ease with which corporations can seek tax abatements through Ch. 313, the lack of evidence that Ch. 313 programs are effective in bringing jobs & investment of value to our local communities, and the way schools are continuously cheated out of property taxes that would otherwise be fairly paid, are all reasons why this program should be ended. Thank you.
