Determine whether law enforcement needs specific or individualized training or education on matters involving border security, human trafficking or other scenarios where unaccompanied minors are involved.
- C. Monitor the recent surge in border crossings and make recommendations for enhancing safety and security of law enforcement, civilian populations on both sides of the Texas-Mexico border, and those entering the United States.
