Pursuant to a notice posted in accordance with Senate Rule 11.10 and 11.18, a public hearing of the Senate Committee on Criminal Justice was held on Wednesday, May 12, 2021, in the Capitol Extension, Room E1.028, at Austin, Texas.

Senator Bettencourt moved that HB 39 do not pass but that CSHB 39 be reported back to the Senate with the recommendation that it do pass and be printed. The motion carried with a record vote of 7 ayes, 0 nays, 0 present not voting, and 0 absent.

Senator Bettencourt moved that the bill be recommended for placement on the Local & Uncontested Calendar; without objection, it was so ordered.

The chair laid out HB 1403 and recognized the Senate sponsor, Senator Huffman, to explain the bill.
