

**NOTICE OF INTENT TO INTRODUCE A BILL**

Pursuant to the Constitution and laws of the State of Texas, notice is hereby given of the intention to apply to the 87th Legislature of the State of Texas at its regular session in Austin, Texas for the introduction of a bill, the substance of the contemplated law being as follows: An act relating to the issuance of bonds by Chambers County Improvement District No. 1; exempting Chambers County Improvement District No. 1 from the requirements of 375.243, Texas Local Government Code which includes the receipt of a petition signed by the owners of a majority of the assessed value of the property subject to assessment or taxation by Chambers County Improvement District No. 1 as determined from the most recent certified county property tax rolls and the requirements of 3854.209, Special District Local Laws Code, which prohibits Chambers County Improvement District No. 1 from issuing bonds payable from an ad valorem tax imposed over the entire district in an amount more than the greater of \$50 million or 10 percent of the assessed value of the taxable property in the entire district as shown on the most recent certified tax rolls of the county central appraisal district unless the Texas Commission on Environmental Quality approves the feasibility of district bonds. All interested persons will, therefore, take notice of the matters and facts set out in the foregoing statement of the substance of the contemplated laws as required by the Constitution and laws of the State of Texas.
