



**NOTICE OF INTENT TO INTRODUCE
LEGISLATION**

This is to give notice of intent to introduce in the 87th Legislature, Regular Session, a bill to be entitled an Act relating to the creation of Creedmore Municipal Utility District, a special district operating under Section 52, Article III, and Section 59, Article XVI, Texas Constitution and Chapters 49 and 54, Texas Water Code, providing authority for the District to impose assessments, fees or taxes and issue bonds and granting a limited authority of eminent domain, affecting lands in Travis County, Texas, being generally located approximately 212.934 acres of land within the Extraterritorial Jurisdiction of the City of Creedmore of 134 acres out of the Elijah Caples League Survey No. 7, Abstract 155, Travis County and 78.934 acres in the William P. Corbin Survey, Abstract No. 159, Travis County. The property is generally located at the southeast intersection of SH-45 and FM 1625.
