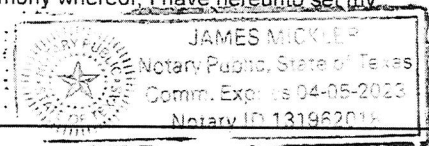

NOTICE OF INTENT TO INTRODUCE
LEGISLATION

This is to give notice of intent to introduce in the 87th Legislature, Regular Session, a bill to be entitled an Act relating to the SH130 Municipal Management District No. 1, a special district operating under Sections 52 and 52-a, Article III, and Section 59, Article XVI, Texas Constitution; and Chapters 372 and 375, Texas Local Government Code, relating to the powers and duties of the special district, affecting lands to include: 1138.58 acres of land in or near the City of Austin, Travis County, Texas, being generally located as follows: 4 tracts generally located west of SH130, north of FM973, south of Bloor Road and east of Walter E. Long Metropolitan Park. 1 tract generally located East of SH130, West of Gilbert Lane, South of FM973 and North of Decker Lake Road. 1 tract located North of FM 969 and West of Burleson Manor Road and 2 tracts located South of FM 969 just South of the Burleson Manor Road and North of the Colorado River.
