The Coalition of Texans with Disabilities believes in strong public policy that protects and benefits Texans with disabilities, their families, service providers, and communities. We are the largest and oldest member-driven cross-disability organization in the state.

As a person with lived experience in the justice system, I know the importance of redemption. I was 15 years old when I was given a 20-year sentence, with eligibility for parole after 10. This was a tough sentence but nothing compared to many of the teenage girls who were incarcerated along side of me. These girls, who are now middle aged, are still working on sentences that range between 50 to 70 years. I know their stories intimately, stories of childhood abuse, undiagnosed mental health problems,

and desperation, because these stories are my own.

Youth who receive the harshest punishments in the criminal justice system are those who have the highest level of vulnerability. Studies show that prior to committing an offense, these children have witnessed violence in their homes and/or communities, and experienced trauma such as physical and/or sexual abuse.

Almost two decades of research by experts shows that very few of these children go on to commit serious crimes as they get older. They grow out of behavior that is often a product of chaotic and traumatic childhood experiences, and begin to develop normal adult impulse control.

We know that long term incarceration of these children increases their risk for the early development of chronic illnesses and disabilities. They also become “institutionalized”, having trouble thinking and acting independently because they were forced to conform to the institution for survival. Upon release they then become dependent on public programming and are most likely to reside in shelters or transitional housing.

HB 686 would allow kids a chance to move beyond their childhood mistakes, and develop a meaningful adult life on the outside. While the state is responsible for making sure that they are accountable for their actions, it must also itself be held accountable for ensuring that children have a reasonable opportunity for rehabilitation and a return to society.

We were never the “superpredators” of the 1990s, children who pseudo-scientific research claimed were beyond reach and without remorse. Data proved this inaccurate. My own success and the quiet preserving spirit of the women I know prove it wrong. The superpredator theory is a thing of the past, yet the children, families, and communities it affected the most continue to be harmed by its legacy. With HB 686 legislators are now tasked to usher in the hope of redemption to those of us who were told there was none.

As the parents of a murdered son, and whose murder involved a juvenile, we request your support in opposing SB686 because it would be cruel to victims. If violent juvenile offenders are certified to stand trial as adults and are sent to prison, HB 686 could make them eligible for release on parole much earlier than under current law if given a lengthy sentence, which demeans the severity of their crimes, and devalues victims. These juveniles caused irreversible damage, and parole hearings will trap victims in a never-ending cycle of trauma.

If a 16-year old gets to start parole hearings after 20 years, that means victims will have to attend parole hearings every 2 (!) years, starting at the offender's young age of 36. The offender would get hearings at 36, 38, 40, 42, 44, 46, 48, 50, 52, 54, 56, 58, 60 and so on. Victims must participate in these hearings, revictimizing them over and over again for many years. Multiple generations would need to relive the nightmare every two years. Victims need and deserve finality, not revictimization. We feel that when a 16-year old is convicted in an adult court, and is given a long sentence, it would be highly inappropriate for them to potentially be released at the age of 36, especially if their victims didn't get to live, some not even past the age of 2 (see Jose "Lalo" Eduardo Arredondo (16) Victim: Katherine Cardenas, age: 2, Crime: Kidnapping, abduction, rape, child cruelty, & murder, Laredo, TX Sep 5, 2009). There is no second chance or do-over for victims of violent crimes.

On June 24, 2020, our 26-year-old son Christopher was robbed, brutally assaulted, and murdered by five individuals in Travis County. One of the five was 16 at the time, and was charged with aggravated robbery. The 16-year old went on to commit armed robberies in Williamson County after our son's murder and was charged there as well. The 16-year-old was one of the more sadistic ones that continued to assault our son after he was beaten unconscious during the robbery, breaking his face and bones. Our son was then shot to death. We searched for 37 days until we found his body in a cornfield in Manor, Texas. Our son had to have a closed casket because none of the five talked. They even took away our ability to say a final goodbye to our only son, which was absolutely devastating.

We are worried that once juveniles are given sentences that are proportionate to the extremely violent crimes they committed, this new legislation will be used to drastically shorten these sentences.

Existing Texas laws acknowledge that those under 18 and 21 do not have the same rights and privileges as mature adults. Those laws are based on what has long been known about "under-age" individuals.....they are not as culpable as adults and thus should not be held to the same standards. The U.S. Supreme Court has held that juveniles are different and that difference should be a mitigating factor in determining legal responses to lawbreaking. Neuroscientists have clearly established that young adults' brains are still maturing, and this needs to be considered in how they are dealt with. The U.S. Armed Forces actively recruit young adults precisely because of their ability to change and adapt to the requirements of defending our country. Juvenile Courts were established 100 years ago because of the long-known fact that young adults need to be treated differently than mature ones.

The American Law Institute, creators of the Model Penal Code, updated the code in 2017.
(<https://robinainstitute.umn.edu/news-views/new-model-penal-code-criminal-sentencing-approved-american-law-institute-comprehensive>)

"(2) There is always an exemption from mandatory in the Code for juveniles who have been tried as adults. (3) All sentencing courts are given an "extraordinary departure power" to override the force of mandatory minimums "when extraordinary and compelling circumstances demonstrate in an individual case that the mandatory penalty would result in an unreasonable sentence." (4). The MPCS gives every prisoner an opportunity for a judicial "second look" at their sentence after 15 years, no matter how long their original sentence, and even if their original sentence includes a mandatory minimum prison term of greater than 15 years.

Texas prisons now contain hundreds of Second Lookers serving extremely long prison terms. Many of them have transformed themselves into responsible, mature adults. If you could visit them, review their institutional records, and speak with correctional staff who know them, you would see that further incarceration makes no moral or economic sense. It is time Texas move beyond the “one size fits all” model that has dominated parole policy. One way to implement the conservative idea that “prisons are for those we’re afraid of, not the ones we’re mad at” is by voting HB 686 out of committee and on to the House for due consideration.

The Model Penal Code recommends review at 15 years. What you are considering does so at 20 years. Supporting HB 686 is a modest step in a sensible direction.
