Relating to the temporary relocation of a residential child-care facility during a declared state of disaster.

Relating to the regulation of referral agencies for senior living communities; providing a civil penalty.

HB 3041 Frank
Relating to the procedures and grounds for taking possession of a child and authorizing a family preservation services pilot program as an alternative to removal in suits affecting the parent-child relationship.

HB 3044 Howard
Relating to certain criminal history record information obtained by home and community support service agencies.

HB 3379 Lemman
Relating to the duty to report child abuse and neglect.

HB 3662 Buckley | et al.
Relating to the award of health plan provider contracts under the Medicaid managed care program.

HB 3820 Klick
Relating to health care specialty consultations in certain child abuse or neglect investigations and assessments.
