HB 701 Walle | et al. Relating to simplified certification and recertification requirements for certain persons under the supplemental nutrition assistance program.

HB 945 Romero, Jr. | et al. Relating to the period of eligibility of certain persons for supplemental nutrition assistance program benefits.

HB 1098 Gates Relating to reports of child abuse or neglect and certain preliminary investigations of those reports.

HB 1230 Ortega Relating to excluding the value of motor vehicles in determining eligibility for the supplemental nutrition assistance program.

HB 1353 Ortega Relating to continued household eligibility for supplemental nutrition assistance program benefits on the ineligibility of the head of household for failure to comply with certain work requirements.

HB 1449 Romero, Jr. Relating to the exclusion of certain resources in determining eligibility for financial assistance and supplemental nutrition assistance program benefits.

HB 1681 Harless Relating to the construction of an assisted living facility within a 500year floodplain. HB 2126 Walle Relating to eligibility for the supplemental nutrition assistance program and the provision of employment and training services under the program. HB 2298 Cason | et al. Relating to notifying an alleged perpetrator of child abuse or neglect of the person's rights in connection with an investigation conducted by the Department of Family and Protective Services. HB 2365 Lopez Relating to the participation and reimbursement of certain military medical treatment facilities and affiliated health care providers under Medicaid. HB 2641 Rodriguez Relating to annually adjusting for inflation the maximum amount of a motor vehicle excluded in determining eligibility for the supplemental nutrition assistance program. HB 3191 Meza | et al. Relating to prohibiting or limiting certain charges during a public health disaster in connection with delivery services provided by retailers participating in the supplemental nutrition assistance program. HB 3225 Hinojosa Relating to the reimbursement under Medicaid of local educational agencies for the provision of health care services to students. HB 3287 González, Mary | et al. Relating to the provision of certain co-navigation services to persons who are deaf-blind. HB 3419 Guillen Relating to the participation and reimbursement of certain children's hospitals under Medicaid. HB 3425 Slawson Relating to the drug testing of certain persons seeking benefits under the Temporary Assistance for Needy Families (TANF) program. HB 3493 Parker | et al. Relating to prevention and early intervention services by the Department of Family and Protective Services. HB 3815 Hunter Relating to transitional living services provided to foster youth transitioning to independent living.

HB 4094 Frank Relating to procurements by Health and Human Services Agencies and exemptions for contracts entered into by the Department of Family and Protective Services.
