Relating to a suit for possession of or access to a child by a grandparent.

Relating to the admission by a party of a material and substantial change of circumstances in a motion to modify an order in certain family law cases.

HB 853 Cook  
Relating to possession of and access to a child less than three years of age.

HB 865 Thompson, Senfronia  
Relating to spousal maintenance.

HB 867 Thompson, Senfronia  
Relating to the issuance of a qualified domestic relations order for the payment of spousal maintenance and child support obligations.
