Relating to the authorized activities of a manufacturer's agent's
warehousing permit holder.

HB 3985 Huberty
Relating to the offense of providing an alcoholic beverage to a minor;
increasing a criminal penalty.

HB 4016 Kuempel | et al.
Relating to operating agreements between holders of a distiller's and
rectifier's permit and certain alcoholic beverage permit holders.

HB 4184 Guillen
Relating to the licensing and regulation of certain drug and alcohol
related court-ordered educational programs; providing administrative
penalties; requiring occupational licenses; authorizing fees; creating
criminal offenses.
