HB 3391 Turner, Chris | et al. Relating to fees paid to a third party in connection with certain extensions of consumer credit. HB 4108 Guerra Relating to a transfer of ownership for a perpetual care cemetery.

HB 4116 Turner, Chris | et al. Posting Rule Suspended Relating to credit services organizations and extensions of consumer credit facilitated by credit services organizations.

HB 4131 Parker Relating to the self-directed and semi-independent status of the State Securities Board; authorizing fees.

HB 4266 Shine Relating to credit repair services performed by a credit services organization.

HB 4307 Lucio III | et al. Relating to coverage for low-THC cannabis under certain group benefit plans for governmental employees.

HB 4474 Parker Relating to the control of virtual currency and the rights of purchasers who obtain control of virtual currency for purposes of the Uniform Commercial Code.

HB 4477 Thompson, Senfronia Relating to the financial exploitation of certain vulnerable adults.
