SB 343 Kolkhorst | et al. Relating to the entry into the Texas Crime Information Center of certain information regarding conditions of bond imposed in criminal cases involving family violence.

SB 550 Springer | et al. Relating to the manner of carrying a handgun by a person who holds a license under Subchapter H, Chapter 411, Government Code.

SB 1253 Hall | et al. Relating to the issuance and renewal of licenses to carry a handgun for purposes of reciprocity with other states.
