HB 2429 Meyer Relating to the alternate provisions for ad valorem tax rate notices when the de minimis rate of a taxing unit exceeds the voter-approval tax rate.

HB 2510 Noble | et al. Relating to a sales and use tax exemption for animals adopted from or sold by nonprofit animal welfare organizations.

HB 2625 Noble Relating to excluding the furnishing of an academic transcript from the definition of "information service" for purposes of sales and use taxes.
