If providing written testimony, bring **20 copies, with your name on each copy**, to E1.028. All written testimony will be distributed to the Committee Members after the hearing. Those registering a position-only may do so at any Senate kiosk by the end of the hearing.

- Oral testimony: fill out a paper witness card in E1.028 and submit to SFC staff.
- Oral and written testimony: fill out a paper witness card in E1.028 and submit your witness card and written testimony to SFC staff.
- Position only: register using the Senate kiosk located in the extension hallways or by going to http://swrs on public-capitol. Kiosk registration will open 30 minutes before the hearing begins.
- Written testimony only: register your position using the Senate kiosk and then bring 20 copies, with your name on each copy, to E1.028 and submit to SFC staff.
