Invited Testimony:

Agencies and other invited witnesses must submit any written materials 2 full business days before their hearing date. Please submit 50 copies to the Committee, and 6 copies to the Legislative Budget Board. The hearing schedule is subject to change. Agencies should consult the postings regularly and maintain contact with Committee staff.

Public Testimony:

Anyone wishing to provide oral public testimony must register in E1.028 by **noon or upon recess of the Committee hearing, whichever may come first.** Oral testimony is limited to 3 minutes. If providing written testimony, bring **20 copies, with your name on each copy,** to E1.028. All written testimony will be distributed to the Committee Members after the hearing. Those registering a position-only may do so at any Senate kiosk by the end of the hearing.

- **Oral testimony:** fill out a paper witness card in E1.028 and submit to SFC staff.
- **Oral and written testimony:** fill out a paper witness card in E1.028 and submit your witness card and written testimony to SFC staff.
- **Position only:** register using the Senate kiosk located in the extension hallways or by going to <http://swrs> on public-capitol. Kiosk registration will open 30 minutes before the hearing begins.
- **Written testimony only:** register your position using the Senate kiosk and then bring **20 copies, with your name on each copy,** to E1.028 and submit to SFC staff.
