- **Oral testimony:** fill out a paper witness card in E1.028 and submit to SFC staff.
- Oral and written testimony: fill out a paper witness card in E1.028 and submit your witness card and written testimony to SFC staff.
- **Position only:** register using the Senate kiosk located in the extension hallways or by going to http://swrs on public-capitol. Kiosk registration will open 30 minutes before the hearing begins.
- Written testimony only: register your position using the Senate kiosk and then bring 20 copies, with your name on each copy, to E1.028 and submit to SFC staff.

The afternoon hearing will reconvene after the Senate adjourns when in session.

SP: Nichols Relating to the exemption from sales and use taxes for items sold by a nonprofit organization at a county fair. Ellzey | et al. SP: Birdwell HJR 125 Proposing a constitutional amendment to allow the surviving spouse of a person who is disabled to receive a limitation on the school district ad valorem taxes on the spouse's residence homestead if the spouse is 55 years of age or older at the time of the person's death.
